Whereas, the members of this City Council have noted with sincere regret the death of Thomas H. Cotter in Detroit, Michigan on January 24, 1961 and

Whereas Mr. Cotter, as a member of our fire department gave to the people of Providence nearly a half century of devoted and exemplary service which - begun in 1904 and finished in 1951 when he resigned because of ill health -- embraced every grade from Probationer to Chief of the department, and

Whereas his training, skill and knowledge, coupled with a kindly and co-operative disposition, provided the leadership for a fire-fighting force that has brought honor and renown to our city as is evidenced by the many national awards for the saving of life and property. During his long service, he saw many changes, prominent among them being the mechanization of equipment and a very substantial reduction in the hours of work. In the late 1940's six modern stations went into service in strategic locations, resulting in the reduction of companies from 37 to 30 with the attendant savings in operating costs, and

Whereas his personal appeal to the City Council for funds to establish a rescue squad was heeded and it has become an outstanding complement of our fire department. As long as these squads continue to roll on their many daily errands of mercy, they will serve as unlettered Monuments to the memory of Thomas H. Cotter.

Now, Therefore Be It Resolved that this resolution be spread upon the records of this city council and a suitably engrossed copy thereof be sent to his daughter, Mrs. Helen McCarter.
