DISPOSITION: The intersection of Eddy Street and Thurbers Avenue is presently under design by the State of Rhode Island under a "3-R" Project for roadway improvements along Eddy Street between Blackstone Street and Thurbers Avenue. The design plan for this intersection has exclusive turn lanes with more visible traffic signal indications. The existing traffic control equipment at this location is very old and cannot accommodate the required turn movements. Since the State of Rhode Island through the Federal Government will be expending funds at this intersection within a year or so, we do not feel that City funds should be expended at this time.






