## TRIBUTE TO THE FLAG OF THE UNITED STATES OF AMERICA

Recitation by John J. Murray, Johnston, Rhode Island, Entitled, "A Lady's Birthday."

### A LADY'S BIRTHDAY

By JOHN J. MURRAY

Like all of you, the free people of this nation, I too have a birthday that I am most proud of. But unlike you, I am 200 years old. That is not so long a time when I fly beside the flags of other nations. However, I am the honored guest among my neighboring sister flags because I have

flown over a free democracy whose concepts have never changed in all these years.

As I approach the Bicentennial of these, The United States, it is with the utmost pride that I still represent the ideals, the people, the government, and the land of the most beautiful and the most free nation on the face of the earth. I shall fly from more homes, schools, public and private places of business. I shall hang in pride and glory in many religious temples of all faiths. I shall fly from all the ships at sea that come under my protection and care as I fly now from

the North Pole where I was planted in 1909 by Admiral Perry. I also very proudly remain planted on the moon as first set foot upon by some of my sons, all Americans.

As you all like to recall where you came from and how you were named, so also do I. On June 14, 1777, the Continental Congress passed a resolution that the 13 original states would be represented by 13 alternating stripes of red and white. The Union would be 13 stars, white on a field of blue, representing a new constellation.

Just prior to my birth, the Revolutionary War had been fought under many different flags, two of which were the Cambridge and the Grand Union Flag. My colors were always the same and so it was ordained that this would not change. I have been called by a beautiful name, "The Stars and Stripes," for so many years. No one knows exactly who gave me this name, but it is a favorite of mine. I am equally proud of another one of my names. I was christened "Old Glory" by a beloved old sea captain, William Driver, who came from Salem, Massachusetts. As if I were not honored enough, I was to be further shown great love and affection by Francis Scott Key in 1814, when he wrote a poem titled "The Star Spangled Banner." It was so dear to me that I suppose my people sensed that I would have loved that poem to become our National Anthem. Thus it was decreed, and so it is now. What a beautiful tribute to a "Grand Old Flag."

When the men of those days decided what I would look like, they set out to have me reproduced in order that I show myself off to the land and the people. My beginning is still a little vague, for as I have flown through history, many have claimed to have first sewn my stars and stripes. A Congressman, Francis Hopkinton, claimed that he designed me. Still others say that a very talented seamstress, Betsy Ross from Philadelphia, made my first garment. But this has never been proven so perhaps I shall never know who first put me together. Nevertheless, I was born of love and great esteem. and so I set out to prove my way in life.

In the earlier years of my existence, I saw many men and women die in the fields of battle throughout the world. So determined they were that I must not be harmed that they faced Civil Wars, Revolutionary War, global wars, and perhaps the most devastating of them all, World War II.

No matter where my sons and daughters have fought, both here and beyond the seas, I have always been their inspiration and, most importantly, their hope. It was and still is my duty to protect their land, their homes and their freedom. I have not failed them in all these 200 years, and I shall never betray this trust.

There have been times in my life when I too have felt the slings of misfortune. I am particularly saddened when I look down at the way I have been discarded and abused by those who have lost faith in me. I have seen myself worn on the back seat of trousers. I have bled at other times when I have seen my image hung upside down by dissenters and those of little faith. I still protect their rights, however, and I still fly more gloriously in all the faces of adversity.

As I grew older and more renowned throughout the world, I added a few more stars to my field of blue. Now I fly over all 50 of the United States. Does this not make me a boastful mother to millions of sons and daughters?

As I look back on my long lifetime, I remember that on April 4, 1818, Congress resolved that I would have a design of 13 stripes, with a star for each state, which would be added on the Fourth of July as each state was admitted to the Union. Thus, I would not be cluttered with more designs, and so it was that I took a look at my new dress.

I neglected to tell you that the red in me stands for courage and hardiness; white, for purity and innocence; blue for vigilance, perseverance and justice. My official birthday is June 14th. With the exception of Pennsylvania, which declares the day a national holiday, all

the other states hold some sort of remembrance of my day. There are parades where I am seen in great array, flying higher than all the other flags and emblems. I am saluted in many ways. I always like to see the children of my nation salute me and pledge allegiance to me at the start of school. It is for them that blood has been shed at home and on foreign fields. It is for them that we carry the torch that was handed down through the years. They are the hope of America. They have a right to look at me and dream their most hopeful dreams. It is for us to help those dreams come true.

Well, now you know a little more about me. You call me "Old Glory." I call you "Old Faithful." So hoist me to the heights of the skies, for I fly under the guidance of the Supreme God of all men. I am liberty. I shall listen to "The Star Spangled Banner" echo from the mountains, to the prairie, and from ocean to ocean. Let no friend or foe make the mistake that I can easily be taken for granted. For as I have led the battles of history in your behalf to remain free, then shall I take up the cause if the time calls for it again. Pray God that it never does. If you believe in me and love me, as I believe in you and love you, then together we can tell the world. Let the drums roll out! Let my folds

unfurl in the breeze! Let freedom ring! For I am the stars and stripes forever, and you are my free Americans. May the Almighty God in all His love and mercy look down on us from above and cover us with His mantle of love as we raise our voices together: "God bless America, Land That We Love." So, Happy Birthday to you . . . Happy Birthday to me!

**Sec. 4.** This Emergency Ordinance shall take effect upon its passage.
