

# RESOLUTION OF THE CITY COUNCIL

No. 22

Approved January 14, 1977

WHEREAS, Philip J. Holton, Jr., Former Chief Engineer of the Water Supply Board, has departed from this life, leaving a most notable professional legacy in the Service of the City of Providence, and

WHEREAS, during his tenure in that most responsible position, first as Superintendent of the Scituate Reservoir, principal source of Water Supply servicing a great portion of its consumers within the State of Rhode Island and as Chief Engineer, his career saw the development of the system as one of the finest producers of palatable water in the entire civilized world, and

WHEREAS, ever alert to the necessity for development of this most valuable commodity, "Phil" Holton invoked every known and proven engineering advances that users of the system would benefit by its processed product, and



WHEREAS, recognized by his associates as an able Engineer, his Memberships on Boards and Associations testified to his recognized performance and ability,


