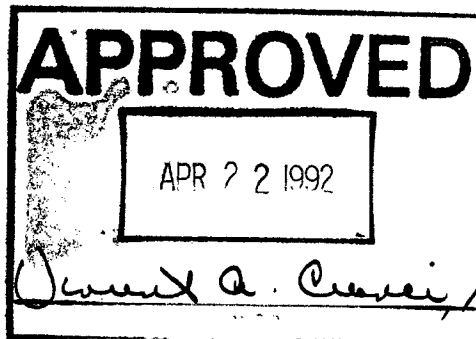

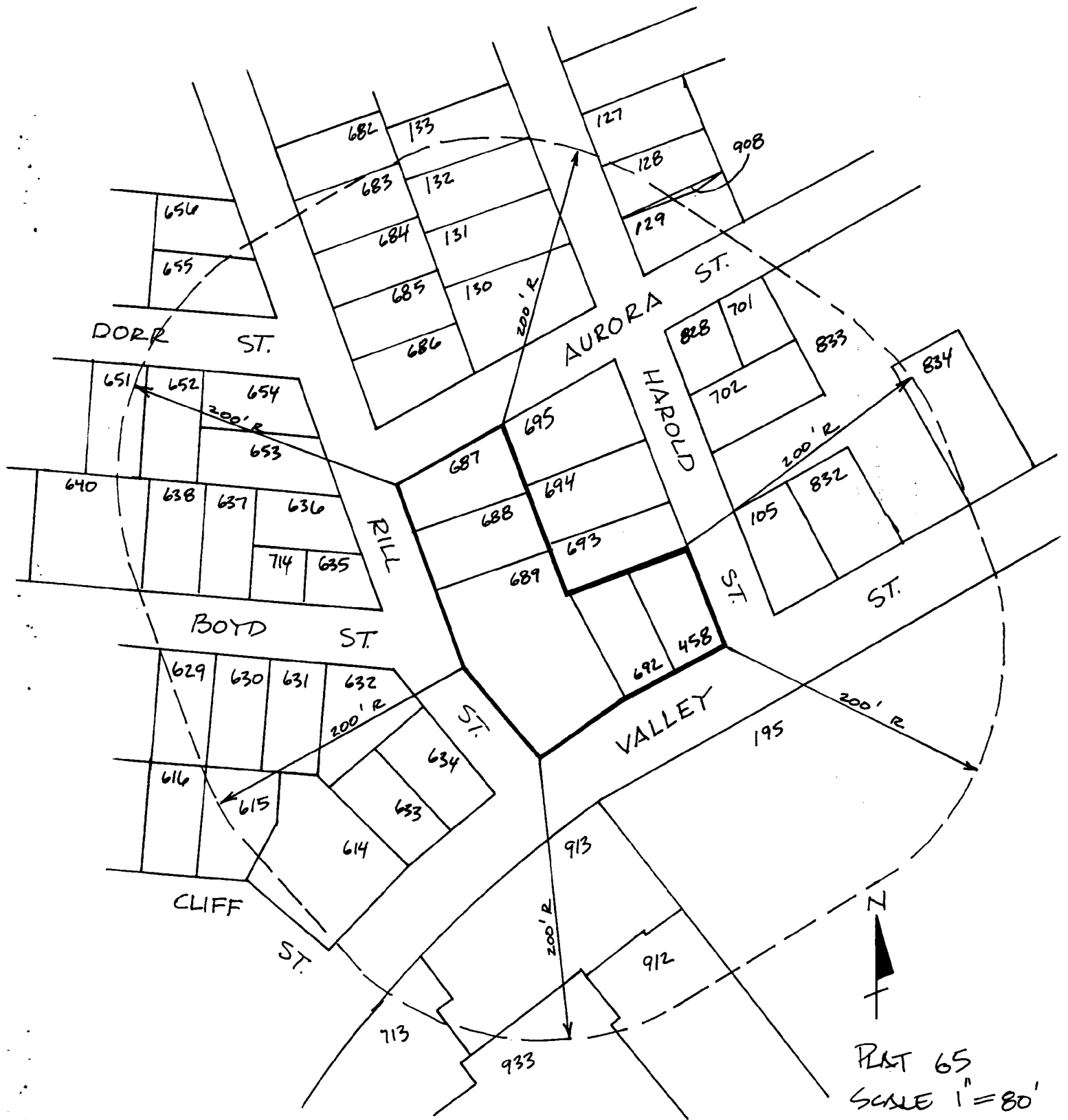



This amendment is required as a result of mapping errors during the preparation of the new zoning maps. Hopefully, this can be corrected in a timely fashion.

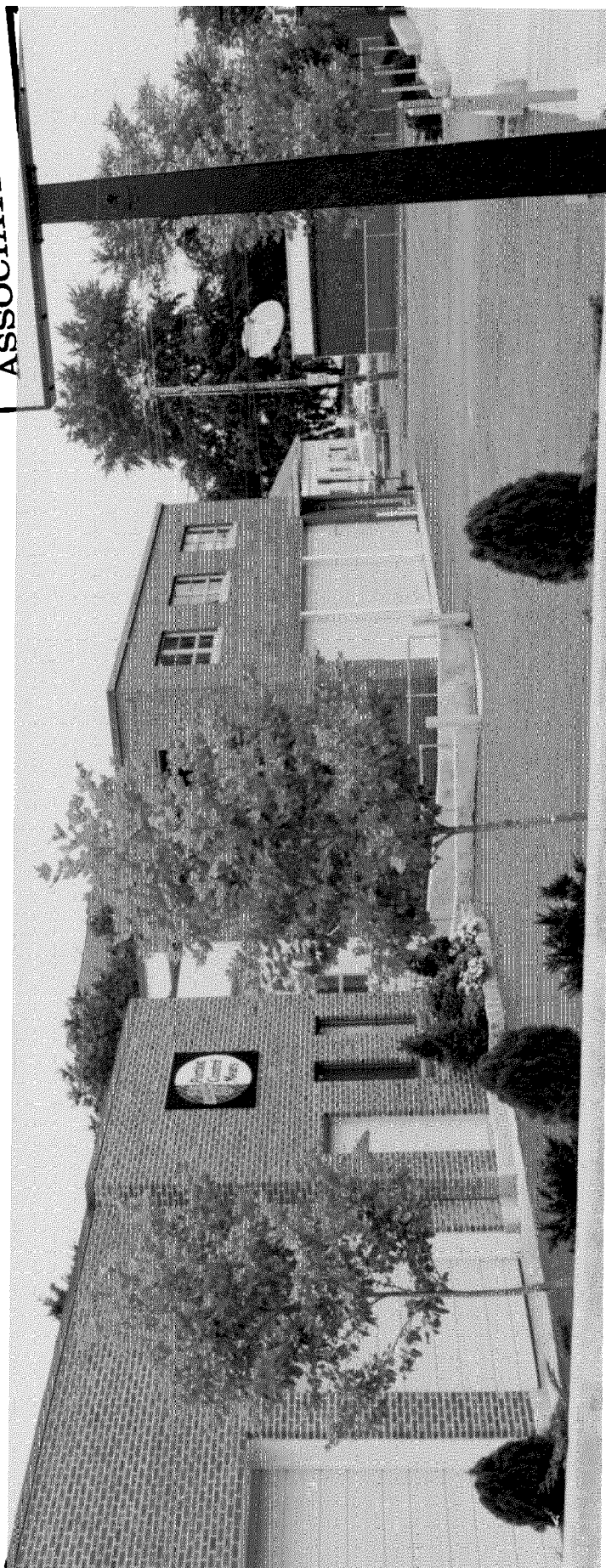

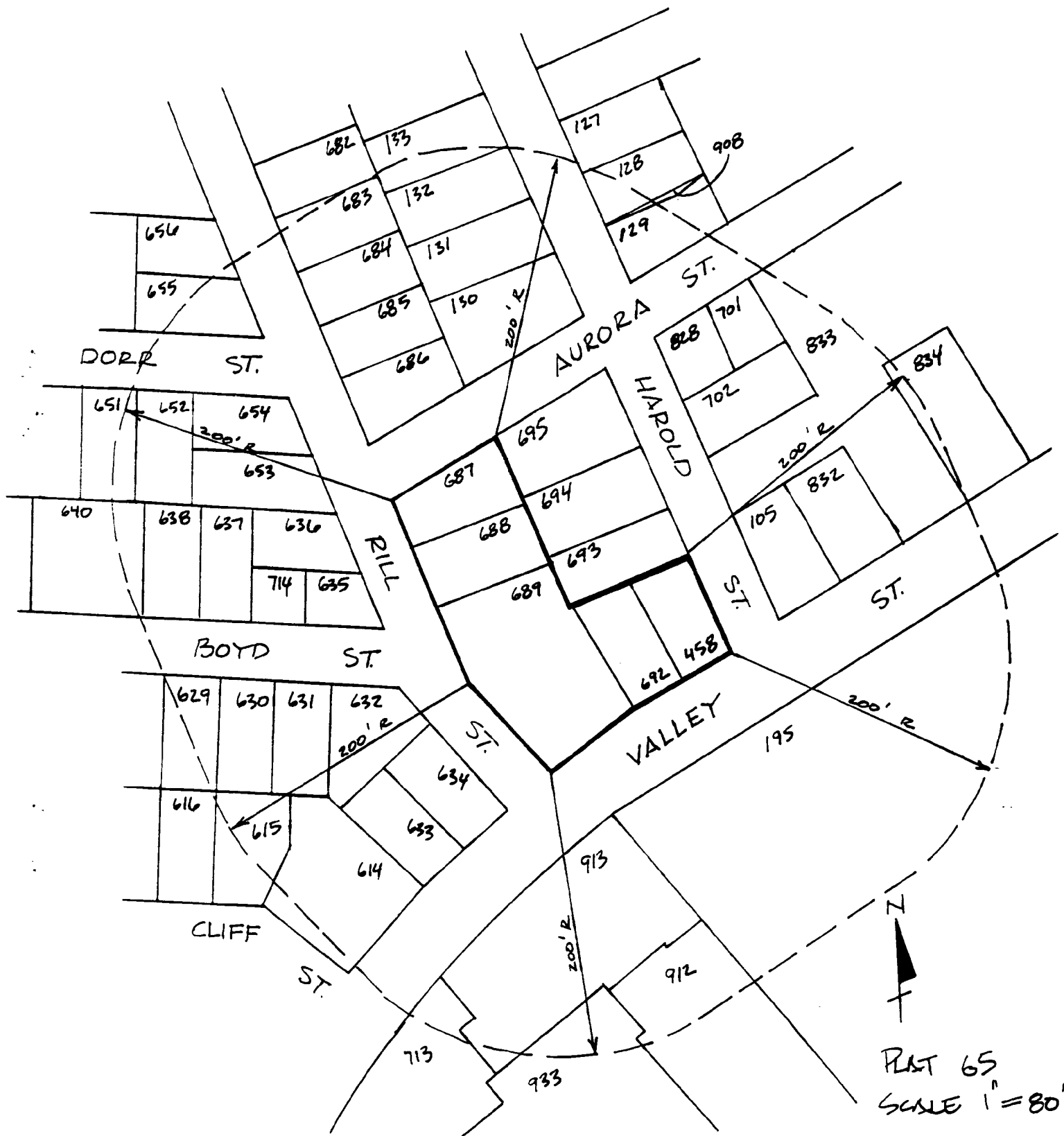
