No. 61 **AN ORDINANCE** IN AMENDMENT OF SECTIONS 22, 23, AND 31 OF CHAPTER 1987-30 AS APPROVED OCTOBER 20, 1987, ENTITLED: "AN ORDINANCE IN AMENDMENT OF CHAPTER 1987-19, APPROVED JUNE 25, 1987, ENTITLED: 'AN ORDINANCE ESTABLISHING THE CLASSES OR POSITIONS, THE MAXIMUM NUMBER OF EMPLOYEES AND THE NUMBER OF EMPLOYEES IN CERTAIN CLASSES IN THE CITY DEPARTMENTS AND REPEALING ORDINANCE CHAPTER 1986-31, APPROVED JUNE 26, 1986,' AS AMENDED" RELATIVE TO THE DEPARTMENT OF INSPECTION AND STANDARDS.

Approved February 11, 1988

Be it ordained by the City of Providence:

SECTION 1. Sections 22, 23, and 31 of Chapter 1987-30 of the Ordinances of the City of Providence, as approved October 20, 1987, as amended, are hereby amended to read as follows:

SECTION 22. The number of employees in the Department of Inspection and Standards Administration shall not exceed twenty (20). There shall be no more than:

- 1 Director of Inspection & Standards
- 1 Deputy Director/Building Safety
- 1 Administrative Coordinator
- 2 Clerk Typist II
- 1 Secretary, Review Boards
- 1 Clerk Typist I
- 4 Clerk IV
- 6 Clerk Stenographer III
- 1 Clerk III
- 1 Recording Secretary, Boards of Review
- 1 Clerk Stenographer III (Part Time)

SECTION 23. The number of employees in the Department of Inspection and Standards Structures & Zoning shall not exceed fourteen (14). There shall be no more than:

- 1 Chief Structures & Zoning
- 1 Plan Estimator
- 1 Supervisor Structures and Zoning
- 1 Assistant Supervisor Structures and Zoning
- 1 Zoning Assistant
- 1 Building Inspector III
- 4 Building Inspector II
- 4 Building Inspector I

SECTION 31. The number of employees in the Department of Inspection and Standards-Prosecution shall not exceed five (5). There shall be no more than:

- 1 Legal Secretary (Prosecution)
- 1 Prosecution Coordinator
- 1 Assistant Prosecution Coordinator
- 2 Assistant Legal Secretary

SECTION 2. This Ordinance shall take effect upon its passage.

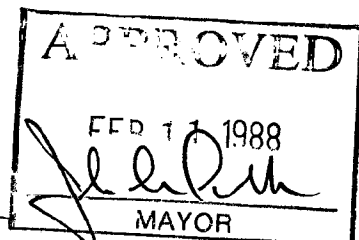
