# RESOLUTION OF THE CITY COUNCIL

No. 474

Approved October 26, 1971

WHEREAS, LaSalle Academy, sponsored by the Roman Catholic Diocese of Providence and conducted by the Brothers of the Christian Schools, more popularly known as the Christian Brothers, was founded by the Diocese and the Brothers in September of 1871, and

WHEREAS, the current academic year commencing in September of 1971 and concluding in June of 1972 marks the one-hundredth anniversary year of LaSalle's founding and one-hundred years of continued operation, and
