# RESOLUTION OF THE CITY COUNCIL

No. 495

Approved December 13, 1972

WHEREAS, 2-1-21 of the General Laws of the State of Rhode Island, entitled, "An Act Relating to Fresh Water Wetlands" provides in part that no person, firm or corporation may excavate, drain, fill, divert water flow into or out of or add to or take from or otherwise alter any fresh water wetlands as defined in 2-1-20 of said Act without first obtaining the approval of the Director of Natural Resources of the State of Rhode Island; and

WHEREAS, said Chapter 2-1-21 also provides that such approval shall not be granted unless the City Council of the City within whose borders the land lies shall approve the same prior thereto; and

WHEREAS, the Providence Redevelopment Agency seeks to dispose of certain land in its East Side Renewal Project, No. R. I. R-4 designated as Parcel 19 E which land is located within an area designated as a "Fresh Water Wetlands" under said Act to Abraham and Bedea Badway, husband and wife and Peter J. and Preziosa Petrarca, husband and wife, a partnership known as Richmond Realty Co.

NOW, THEREFORE, BE IT RESOLVED by the CITY COUNCIL of the City of Providence

1. That the City Council of the City of Providence, pursuant to the provision of 2-1-21 of the General Laws of the State of Rhode Island, hereby approves any excavating, draining, filling, the placement of earth, rock, borrow, gravel sand and other materials upon and the altering of the character of the fresh water wetlands in Parcel 19 E of the East Side Project, No. R. I. R-4 by Abraham and Bedea Badway, husband and wife and Peter J. and Preziosa Petrarca, husband and wife, a partnership known as Richmond Realty Co.
2. This Resolution shall take effect immediately.
