RESOLVED, that His Honor the Mayor is requested to negotiate lease of that City owned property, being land and building formerly used as a railroad station designated as 12 India Street, Providence, to the Holy Rosary Band; ~~the lease to be for a period of five (5) years, with an option to renew for an additional at period of five (5) years One Dollar (\$1.00) per annum;~~ said lease shall include provisions whereby the said lessee shall completely refurbish and maintain the building, assume the financial obligations for payment of water facilities and all other utilities; the said lessee shall not sub-lease the premises, without first obtaining permission, in writing from the Committee on City Property of the City Council.



Proposed Lease of Land and Building Located on Assessor's Plat 18, Lot 80 in the
City of Providence, Rhode Island

That certain tract or parcel of land and building situated in the City of Providence, R.I., shown as cross-hatched area and designated by letters A-B-C-D-A, on the accompanying plan entitled, "Providence, R.I., P.W. Dept. - Engineering Office, City Property Section, Plan No. 063941, Date: July 22, 1975," bounded and described as follows:

Beginning at a point at the northeasterly intersection of India Street and South Main Street and point marked "A" on the accompanying plan; thence in a generally northwesterly direction along the northerly line of South Main Street, fifty and $\frac{13}{100}$ ths (50.13') feet to the northwesterly corner of Lot 80 and point marked "B" on the accompanying plan; thence in a generally easterly direction bounded northerly by land now or lately of Maurania Corp. to the northeasterly corner of Lot herein described and point marked "C" on the accompanying plan; thence in a generally southeasterly direction bounded easterly by land now or lately of Lausall Realty Corp., fifty and $\frac{13}{100}$ ths (50.13') feet to the northerly line of India Street and point marked "D" on the accompanying plan; thence in a generally westerly direction along the northerly line of India Street, one hundred and $\frac{16}{100}$ ths + (100.16 + ') feet to the northeasterly intersection of India Street and South Main Street and point marked "A" on the accompanying plan, said point being point and place of beginning.

Said parcel contains 5,026 + square feet. Parcel is further identified as being 12 India Street.
