WHEREAS, The price of utilities in Rhode Island has continued to rise consistently; and

WHEREAS, Narragansett Electric's rates were increased to 5.5 cents per Kilowatt Hour in June 2003, representing an 8% increase for residential customers; and

WHEREAS, Over 10,000 Rhode Island families have their heat or electricity shut-off each year; and

WHEREAS, No family should go cold in the winter or live without electricity; and


NOW, THEREFORE, BE IT RESOLVED THAT:

Section 1: The Providence City Council hereby supports the Affordable Energy Bargain plan as proposed by ACORN, the George Wiley Center and the Fair Utility Coalition, which will 1) Place a cap on the utility burden at 7% of a family's income and will create a payment structure for back bills, and 2) Will benefit thousands of Rhode Island families and will cost non-eligible customers no more than \$1 per month; and

Section 2: The Providence City Council urges the Public Utilities Commission to implement the Affordable Energy Bargain Plan.

Section 3: That, upon approval, a copy of this resolution be sent to the members of the Public Utilities Commission; ACORN; the George Wiley Center; and the Fair Utility Coalition.


