On Friday, 22 March 1991, I did receive your "INTER-OFFICE MEMO" dated March 20, 1991 in which you requested that I post signs per City Council Resolution #147. The resolution, as approved on March 15, 1991, "RESOLVED, That the Superintendent of the Park Department is requested to enforce the 9:00 o'clock P.M. closing curfew within Blackstone Park and to have signs posted to that effect."

On Friday, 22 March 1991 and Saturday, 23 March 1991, I did acquire and coat with white reflective material - six (6) 12"x18" aluminium sign blanks. I also did layout and cut RED vinyl lettering for the six (6) signs. The wordage on these signs are:

PARK
CLOSED
AT
9:00PM.

POLICE WILL
ENFORCE

Mrs. Derrig, I have created the signs requested by the City Council Resolution (#147) but I do not have the facilities nor do I have the authority to appropriate the manpower and equipment required to install the signs. I am providing you with six (6) signs - respectfully, you have the authority to appropriate the manpower and equipment to install the signs; you also know where these signs are to be installed.

Mrs. Derrig, being that your memo did not indicate how many signs you required and that I chose to create six (6) - please contact me if additional signs are required for this project.

I am forwarding a communication to the City Clerk informing her that I have created the signs and that I have provided the signs to you for installation by Parks Dept. workmen.
