No. **AN ORDINANCE** PROVIDING FOR THE SUBMISSION OF A
CERTAIN QUESTION TO THE VOTERS OF THE CITY.

Approved October 7, 1968

Be it ordained by the City of Providence:

SECTION 1. The Secretary of State is hereby requested to submit the following question to the qualified electors of the City of Providence on Tuesday, November 5, 1968:

"Shall the City of Providence be authorized to issue bonds in a sum not exceeding TWO MILLION FIVE HUNDRED THOUSAND (\$2,500,000) DOLLARS for the costs of land acquisition, construction, furnishing and equipping of a public school building in said City to be used as a special education facility for the handicapped children of said City?"

Section 2. The City Clerk is directed to transmit to the Secretary of State forthwith upon the passage of this ordinance a certified copy thereof.

Section 3. This ordinance shall take effect upon its passage.






