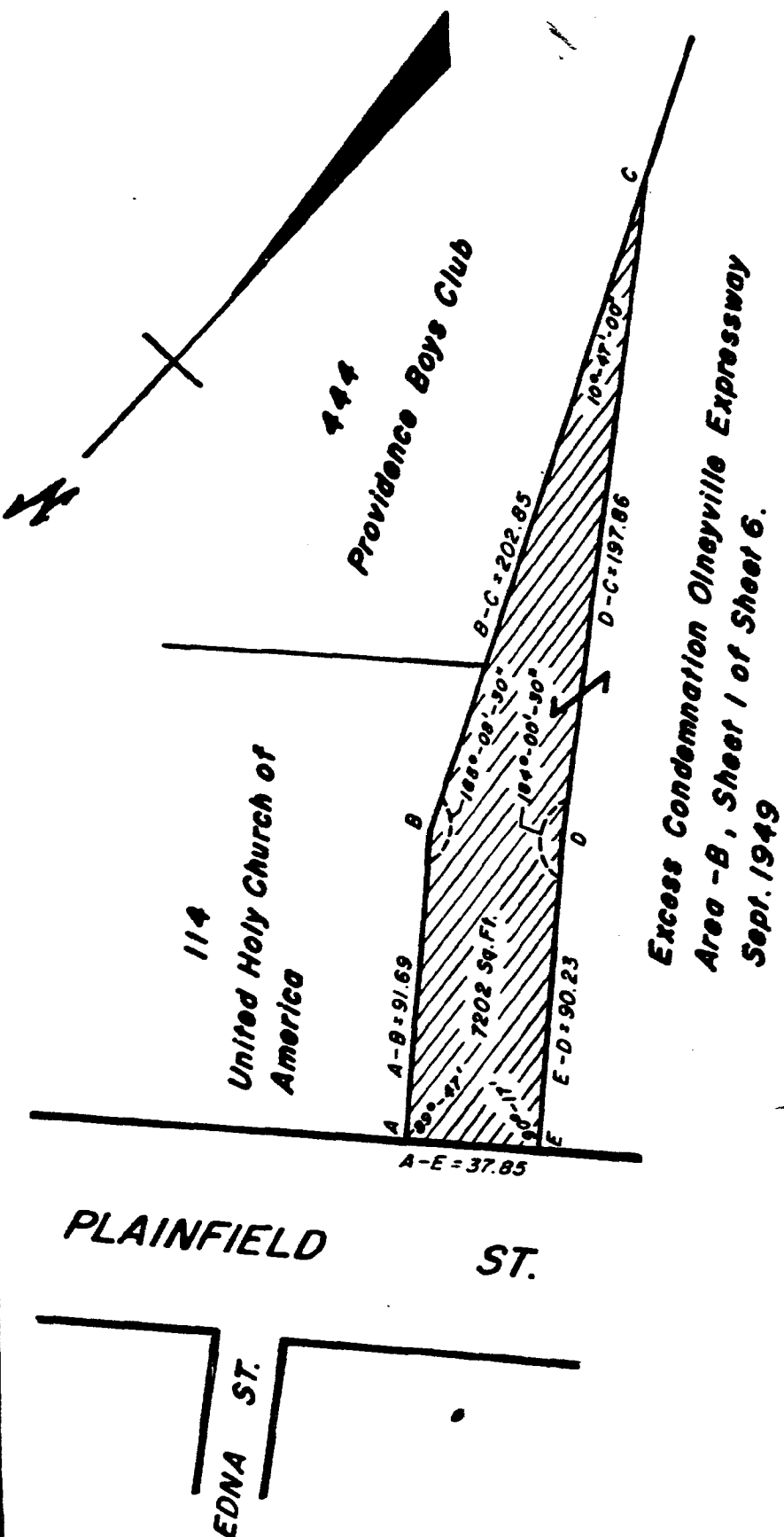

That the CITY OF PROVIDENCE, a municipal corporation, created by the General Assembly of the State of Rhode Island, in the County of Providence, in said State, for and in consideration of the sum of THIRTY-FIVE HUNDRED (\$3500) DOLLARS, to it paid by BOYS & GIRLS CLUBS OF PROVIDENCE, a non-profit Rhode Island corporation, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey unto BOYS & GIRLS CLUBS OF PROVIDENCE, ITS SUCCESSORS AND ASSIGNS forever in fee simple, that certain tract or parcel of land situated in the City of Providence, shown as cross-hatched and designated by the letters A-B-C-D-E-A on the accompanying plan entitled, "Providence, R.I.

P.W. Dept., Engineering Office, City Property Section, Plan

#064145, date May 7, 1981", bounded and described as follows: (Plat 105

Beginning at the point on the southerly line of Plainfield Street, said point being the former Condemnation line of the Olneyville Expressway land and point marked "A" on the accompanying plan; thence generally southeasterly, bounded easterly by land now or lately of United Holy Church of America, ninety-one and 69/100ths (91.69') feet to an angle and point marked "B" on the accompanying plan; thence making an interior angle of 165°-09'-30" and running two hundred and two and 85/100ths (202.85') feet to an intersection and point marked "C" on the accompanying plan; thence making an interior angle of 10°-47'-00" and running northeasterly one hundred ninety-seven and 86/100ths (197.86') feet to an angle and point marked "D" on the accompanying plan; thence making an interior angle of 184°-00'-30" and running ninety and 23/100ths (90.23') feet to the southerly street line of Plainfield Street and point marked "E" on the accompanying plan; thence generally westerly along the southerly street line of Plainfield Street thirty-seven and 85/100ths (37.85') feet to the northeasterly corner of herein described parcel and point marked "A" on the accompanying plan; said point being point and place of beginning; last described line makes an interior angle of 89°-47'-00" with the first herein described line.



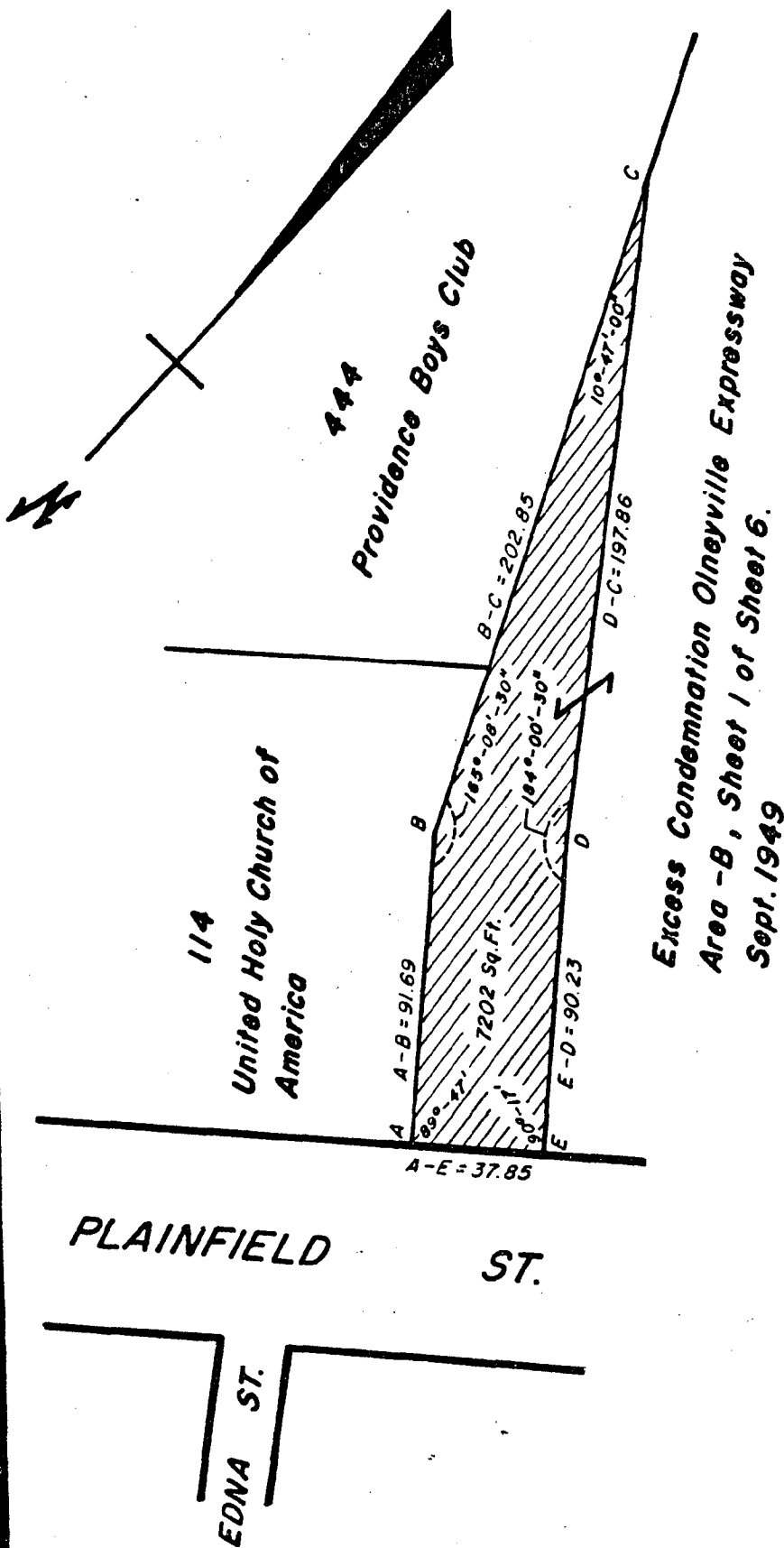
