Whereas, Providence Firefighters have been working without a contract for almost 5 years; and

Whereas, Providence Firefighters have agreed to co-share in the cost of their healthcare; and

Whereas, The failure to resolve this issue has had a demonstrable effect on the morale and working conditions of the men and women of the Providence Fire Department; and

Whereas, We, the elected members of the Providence City Council do not desire to see firefighters work any longer without a fair and equitable contract.

Now, Therefore, Be It Resolved, That this body of elected members of the Providence City Council hereby urges both parties—union and management, to resolve this contract with fair and equitable terms for all interested parties, and

Be It Further Resolved, That this body calls upon the Mayor and the Providence Firefighters Union to resolve this longstanding dispute without further delay; and

Be It Further Resolved, That the members of the City Council along with the residents of the City of Providence, recognize the valuable life saving work performed by the men and women of the Providence Fire Department, their unselfish commitment to the community both on and off duty thru the years and their continuing efforts to improve the quality of life throughout the neighborhoods of the city.

COUNCILMAN BUTLER Requests the privilege of the floor to speak on a Point of Personal Expression and states:

Probably about a month and a half ago when the list came out for streets in wards that the street sweepers would be operating and the times it would be done. I had some concern about the method in which it was being done. I contacted the Director of Public Works and everything that I had said to him a month and a half ago has come true today. I was concerned with the possibility of the wards not getting done in a timely manner, the possibility of rain in the month of May which would cause the backup of many catch basins throughout the City of Providence and last week we witnessed that throughout the City of Providence. Most of the sand and salt that was left from a very difficult winter that we had this year ended up in the catch basins so now we have probably many months of clean-up with catch basins where we get the rain and it's going to continue to backup into peoples front lawns, into their homes, flooding streets and causing the possibility of having accidents because streets are flooded. I had a conversation with the Director last evening and like I said a month and a half ago where he assured me once they got done with the main streets throughout the City of Providence that they would with four sweepers, that they would go into each ward and they would carry on with six. I believe it was last week I stopped and I was talking with the gentlemen who are actually out there sweeping the streets every night which is subcontracted to the City and they believe

that their being slowed down because they only have four sweepers per evening. Where in the past we had six to eight sweepers out. I was explaining to one of my colleagues before the meeting that if we're trying to move a desk that weights 1,500 pounds, if there is four people moving it it's not going to get moved but if you have eight people trying to move it it's going to get moved a little bit quicker. Then again, I spoke with the Director last evening and he believes that the streets in the City look fine. I don't know where he's looking but I travel the City during the course of the day. I've been in the 5th ward, I been in the 6th, I've been in the 12th and I work in the 10th and believe me colleagues the City looks horrible. I would ask you to please call the Director of Public Works and ask him to move his tail, get more trucks out there because it's just not the plowing of City streets that people are concerned about, it's the sand and the salt and there are young children that are out playing on their bicycles slipping on sand and getting injured. So I ask you to call the Director of Public Works and urge him to do whatever he has to do to get this process done. A process that normally took between six and eight weeks we're in our eighth week now and we don't have I believe a quarter of the City done doing it the new way. Some things are not meant to be changed and this is not one that I would recommend be changed and we encourage our Director of Public Works to move it a little quicker. Thank you.
