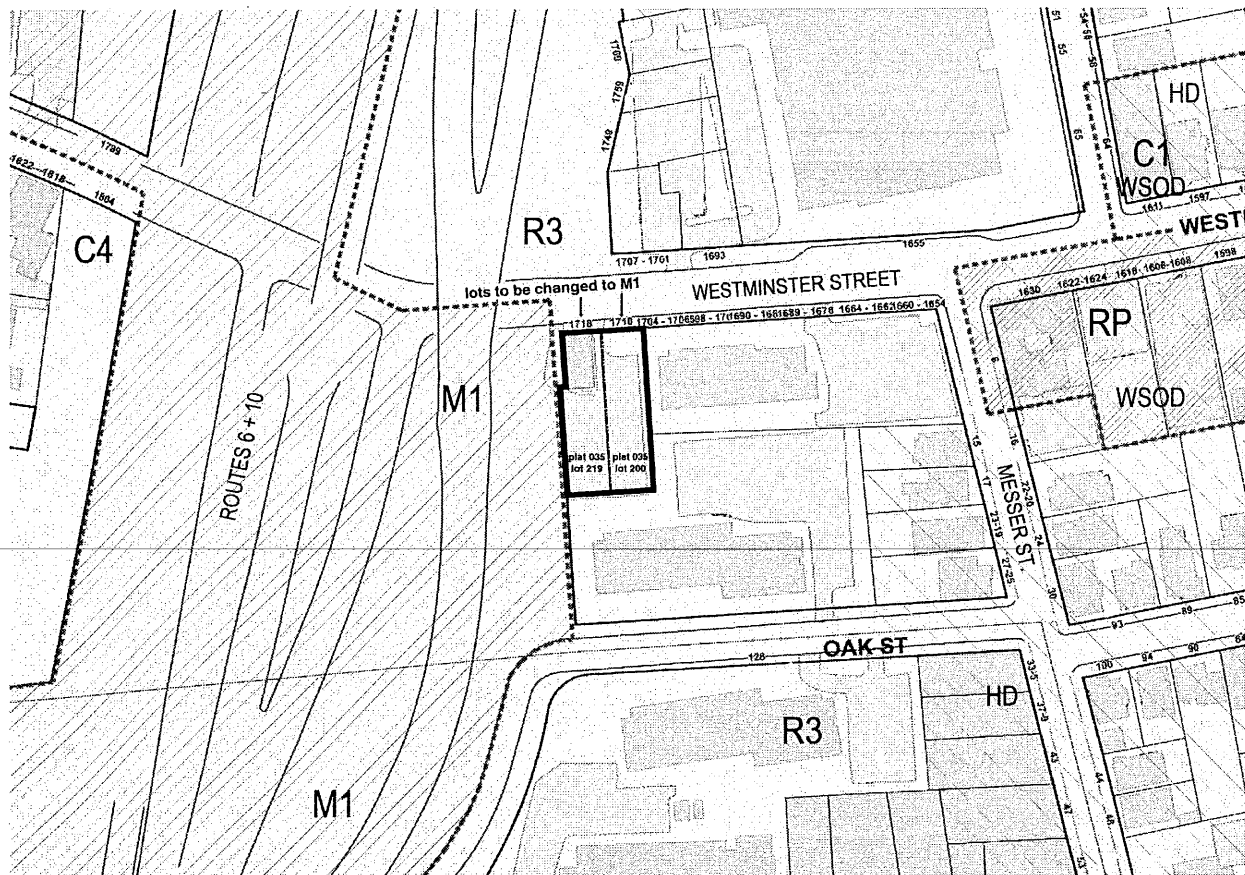
## ORDINANCE(S) SECOND READING

An Ordinance in Amendment of Chapter 27 of the Code of Ordinances of the City of Providence Entitled "The City of Providence Zoning Ordinance," Approved June 27, 1994, as Amended, to Change the Zoning Designation of Property at 1710 and 1718 Westminster St. from R3 to M1

SECTION 1: Chapter 27 of the Code of Ordinances of the City of Providence, entitled "The City of Providence Zoning Ordinance" approved June 27, 1994, as amended, is hereby further amended, as shown on the accompanying map, by changing the zoning designation for the property located at 1710 and 1718 Westminster Street, Plat 35, Lots 219 and 220, from R3 to M1. A note shall be placed on the zoning map that would prohibit drive-through uses on the properties.

SECTION 2. This Ordinance shall take effect upon passage and publication as prescribed by law.

**COUNCIL PRESIDENT SOLOMON, (By Request):**

An Ordinance in Amendment of Chapter 9, Article IV, of the Code of Ordinances,  
Entitled: "Connection of Private Alarm Systems with City System."

SECTION 1. The Code of Ordinances of the City of Providence, Chapter 9, Article IV, Section 9-92 is hereby amended as follows:

**Sec. 9-92. Yearly fee.**

The applicant for this service shall attach to his or her application a check payable to the treasurer of the city, for the yearly fee required for each individual master box number in an applicant's system for the privilege of maintenance and connection to the city's fire alarm system. Such fee shall be due and payable in full on or before the first day of January of each year, but provided that if the service is applied for during the year, the applicant shall pay only that portion of the fee which the unexpired portion of the year bears to the full fee. The director of communications shall annually set the amount of this fee in an amount that recovers the cost to the city for the service rendered to the users, not to exceed five hundred dollars (\$500.00).The

director of communications may also record a lien against the real property for any unpaid charges under this section, and the lien shall be enforced in the same manner provided or authorized by law for enforcement of common law liens on personal property. An exemption for financial hardship may be granted by either the commissioner of public safety or by a majority vote of the city council.

SECTION 2. This ordinance shall take effect upon passage.

## **COUNCILMAN PRINCIPE**

An Ordinance in Amendment of Chapter 27 of the Code of Ordinances of the City of Providence Entitled: "The City of Providence Zoning Ordinance", Approved June 27, 1994, As Amended, to modify Section 401 - Outdoor Uses.

SECTION 1: Chapter 27 of the Ordinances of the City of Providence, entitled "The City of Providence Zoning Ordinance" approved June 27, 1994, as amended, is hereby further amended by changing the following text in Article IV (the text to be removed is crossed out; the new text is underlined):

401.1 - Outdoor Seating: Except in an R-1, R-2, R-3, R-G, and R-M Zone seating for an eating and/or drinking establishment may be provided outside of the establishment. Such seating shall be located on the same lot as the main use or may be located on the adjoining city sidewalk only with the appropriate city permits and/or licenses. The Director of Public Works may approve outdoor seating to encroach into the public right-of-way subject to encroachment regulations adopted by said director. The Director of Public Works may require such seating areas to be delineated through paint or structures to prevent unauthorized encroachments. No additional parking shall be required for such additional seating, provided existing parking is not reduced. Any outdoor seating located within two hundred feet of an R Zone shall cease operation by 11 P.M.

SECTION 2. This Ordinance shall take effect upon passage and publication as prescribed by law.

**COUNCILMAN YURDIN, COUNCILMAN NARDUCCI**

Resolution Requesting Reports on the Results of the Soft Closing Pilot Program.

**WHEREAS**, The Providence City Council has an obligation to ensure the public welfare and good order of the city; and

**WHEREAS**, The City Council in January 2013 issued the Entertainment Licensing and Nightclub Safety Report and Recommendations which identified policies, city ordinances, and state laws that were necessary to maintain and expand a dynamic and robust nightlife in Providence, and to ensure the safe enjoyment of the city's nighttime arts, entertainment, and cultural offerings; and

**WHEREAS**, The City Council worked collaboratively with nightclub owners, residents, and representatives from business improvement and civic organizations, and City officials including the Commissioner of Public Safety, the Chief of Police, and the Board of Licenses to promote a safe and vibrant nightlife in Providence; and

**WHEREAS**, The City Council adopted legislative reforms in 2013 including closing loopholes on floor host registration, creating a new event promoter licensing process, clarifying and expanding the requirements for entertainment licenses, and improving safety and security at commercial parking areas in close proximity to nightclubs; and

**WHEREAS**, The Board of Licenses in 2013 adopted policies and procedures regarding its hearing process; and

**WHEREAS**, While many improvements have been achieved in relation to nightlife policies and regulations in Providence, license violations continue to occur, and violent incidents are reported at or nearby various nightclub venues throughout the city; and

**WHEREAS**, Public safety at nightclubs remains a significant concern for the city; and

**WHEREAS**, A proposal to expand the "soft closing" pilot program-which allows a small number of clubs Downtown which normally close at 2 a.m. on weekends to stay open until 3 a.m.-to include clubs citywide, is currently before the Board of Licenses; and

**WHEREAS**, The results of the pilot program have not been presented to the City Council; and

**WHEREAS**, The proposal to expand the "soft closing" time citywide needs careful study and justification prior to implementation, in order to ensure that the positive gains the City has achieved relating to nightclub safety are not undermined.

***NOW, THEREFORE, BE IT RESOLVED***, That the City Council of the City of Providence does hereby request that the Office of Public Safety Commissioner and the Providence Police Department provide to the City Council a report of the three-year soft closing program and the nightclubs within the pilot (including those that have closed since its inception), to include the following:

1. Public Safety calls and response, from 2011 to present;
2. Documented incidents, from 2011 to present;
3. Documented violations from 2011 to present; and
4. Number of nights additional police officers called from regular posts to respond to incidents, from 2011 to present.

***BE IT FURTHER RESOLVED***, That the City Council requests that the Office of the Public Safety Commissioner present a plan for implementing a citywide 3 a.m. “soft closing,” to include:

1. Allocating police officers and resources at 3 a.m. closing time to manage crowds;
2. Monitoring illegal advertisement of “3 a.m. closing” by nightclubs; and
3. Ensuring compliance with the proposed regulations associated with the 3 a.m. closing, including locking doors at 1 a.m. to prohibit new patrons, turning on lights, lowering the music, and serving only non-alcoholic beverages.

***BE IT FURTHER RESOLVED***, That the City Council requests that the Office of Economic Development provide an analysis of Providence’s nightlife economy and the proposed 3 a.m. “soft closing” to include:

- 1) Comparison of nightclub closing time with other New England cities;
- 2) Models of public safety and crowd dispersal at nightclub closing time in other New England cities;
- 3) Potential economic impact on clubs with capacity of less than 200, which would not be eligible for the program;
- 4) Number of food establishments that should be available to patrons upon exiting nightclubs at 3 a.m., based on experience in other cities with late nightclub closing hours.

***BE IT FURTHER RESOLVED***, That upon approval, copies of this resolution be sent to the Commissioner of Public Safety, the Chief of Police, the Director of Economic Development, and the License Administrator, and that all requested information be provided to the City Council no later than August 1, 2014.


