*The undersigned respectfully petitions your honorable body*

PETITION FOR ABANDONMENT OF CRARY STREET (PORTION)

Rhode Island Hospital, a corporation organized by the General Assembly of the State of Rhode Island, and having its principal place of business in the City of Providence, in said state, respectfully represents:

FIRST: That your petitioner is the owner in fee of all of the land bordering southwesterly on the portion of Crary Street that is sought to be abandoned, the same being approximately one (1) city block in length running from the westerly line of Eddy Street to the southerly line of Borden Street as extended by a suitable arc. Said portion of Crary Street sought to be abandoned is shown with its four corners marked A, B, C, and D, respectively, on the attached drawing.

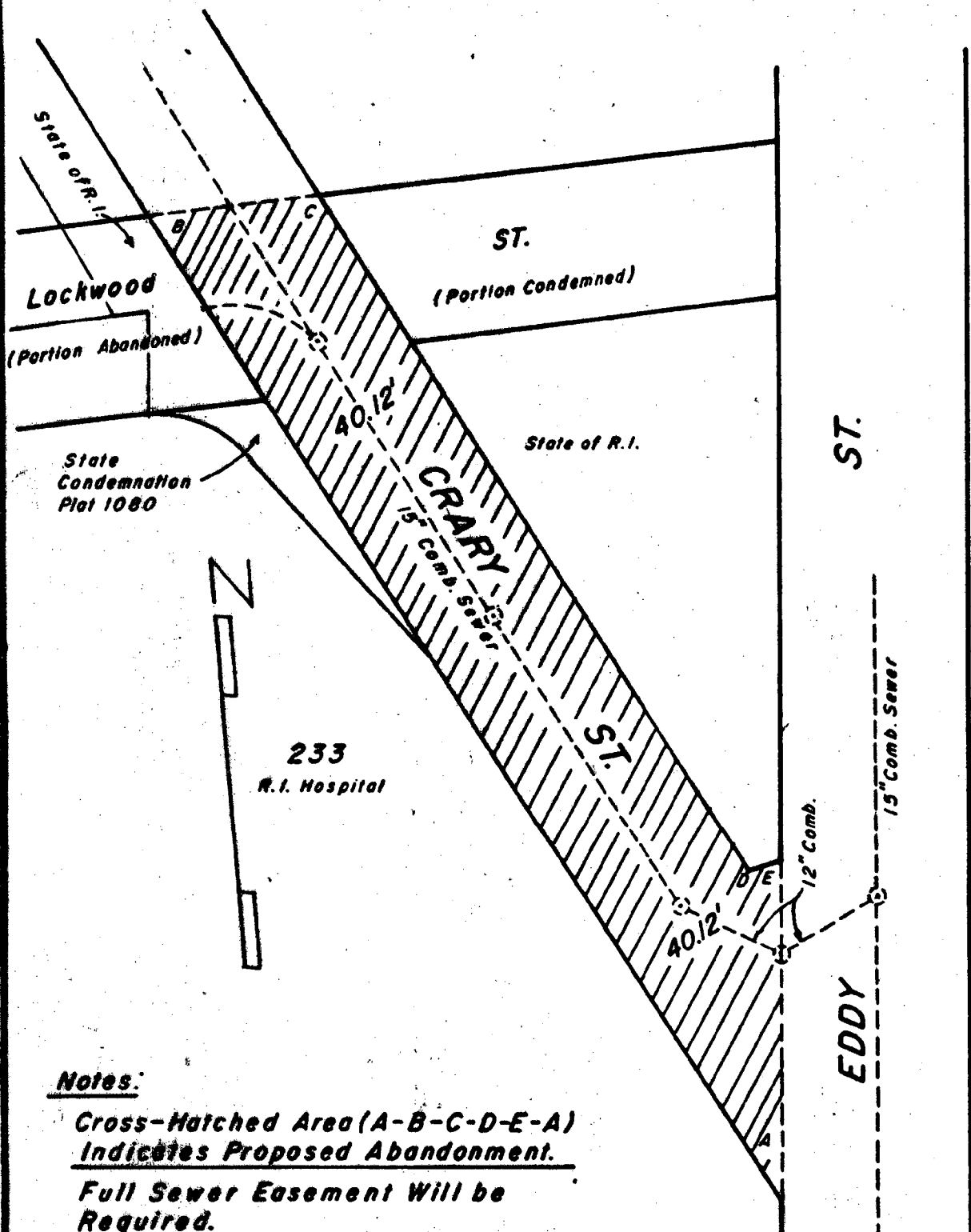
SECOND: Your petitioner is informed and believes that the lands lying northeasterly of that portion of Crary Street sought to be abandoned are owned by the State of Rhode Island being a portion of Interstate Route 95, so called.

THIRD: That the portion of Crary Street sought to be abandoned has been closed to all vehicular traffic for more than one (1) year and has ceased to be useful to the public.

FOURTH: That in the event this Honorable City Council shall see fit to abandon said Crary Street, your petitioner hereby agrees to waive any and all rights to receive compensation from the City of Providence for damages sustained by it by reason of such abandonment and will exonerate and hold harmless said City of Providence from all legal damages, if any, caused to any other person or persons whatsoever and for which said City is or may become legally liable by or on account of such abandonment.

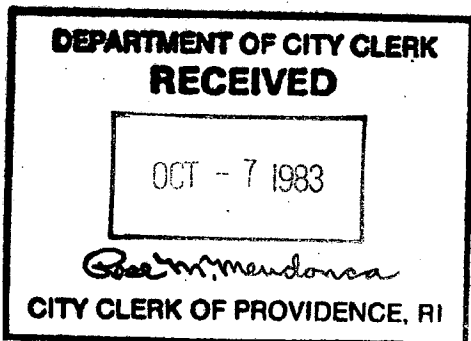

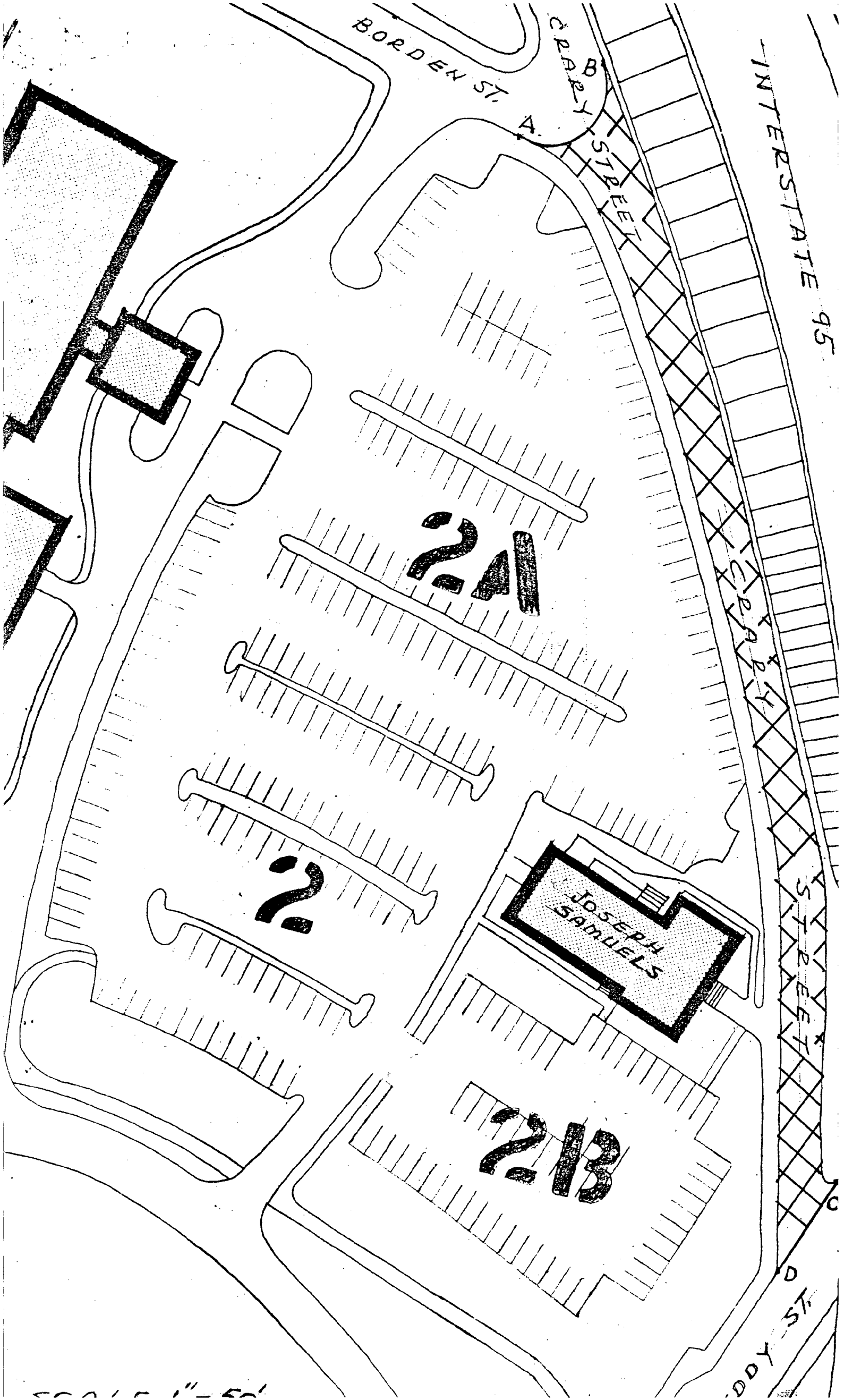

Dear. Mr. Petrosinelli:

My name is Joseph P. Bellino. I am Ear, Nose and Throat surgeon located at 100 Dudley Street, a medical building on the corner of Dudley and Plain Streets in Providence. It is my understanding that that portion of Plain Street between Dudley and Borden is to be condemned at the request of Rhode Island Hospital for the relocation of the new Women & Infants Hospital. I would like to include in Rhode Island Hospital's condemnation request that segment of Plain Street between Dudley and Blackstone Street.

Dudley Street Associates, of which I am a partner, owns the property on both sides of this portion of Plain Street most of which is used for patient parking. As a result of this proposed condemnation, and the necessary rerouting of traffic, there will be increased congestion at this corner, and our patients will have to cross a very busy intersection from the parking lot in order to reach our medical building. We are presently in the process of expanding our facility, and are adding two more floors. This will increase the number of patients coming to our building.

I believe our proposal is more in keeping with your overall plan for this area if this segment between Dudley and Blackstone Street is included.

Dear Councilman Petrosinelli:

This department received a memorandum and a copy of a petition for the abandonment of a portion of Crary Street (Service Road No. 1) from Borden Street to Eddy Street.

The Water Supply Board has a 20-inch feeder water main in Crary Street, running from Borden Street to Eddy Street. This 20-inch feeder main cannot be eliminated as it serves a significant portion of the Rhode Island Hospital general and fire supplies.

The Water Supply Board will accept a permanent easement equivalent to the present street width and length. This area must be accessible to us at all times for any repair work necessary and also include no installations of any permanent type buildings or facilities that could obstruct access.

Gentlemen:

The subject referral was presented to the City Plan Commission at its November 2, 1983 meeting.

The City Plan Commission did not vote on this referral due to lack of a quorum, however this Department has reviewed the subject referral.

A communication was received from the Committee on Public Works dated October 25, 1983, proposing the abandonment of the southern portion of Crary Street between Borden and Eddy Sts. The petition was submitted by Mr. Lloyd L. Hughes, President of Rhode Island Hospital.

A field inspection revealed that the subject portion of Crary Street is a paved public right-of-way with sidewalks. The subject portion of Crary Street has a width of 30 feet and a length of approximately 450 feet. The State of Rhode Island recently widened the Interstate Route 95 by constructing a new retaining concrete wall following the easterly curb line of aforesaid portion of Crary Street for approximately 200 feet. The remaining portion of Crary Street is separated from the State owned land by a wire fence.

The entire subject portion of Crary Street was recently refurbished with a new sidewalk on the western side and a new street base. The street is presently closed to all vehicular traffic pending a final resurfacing.

Crary Street provides an important link between Plain Street and Eddy Street and serves besides R. I. Hospital, several industrial properties located along Borden and Crary Streets.


Considering a potential increase of the traffic volume around Rhode Island Hospital and additional traffic obstacles caused by the abandonment of a portion of Plain Street for the planned

construction of Women & Infants Hospital, it is important from the planning point of view to maintain vehicular traffic movement around the R.I. Hospital area.

Therefore, this Department recommends that this petition be denied.



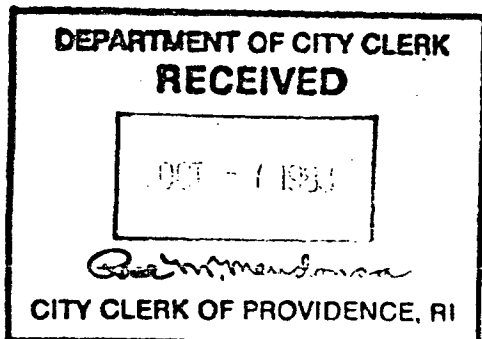


