RE: PENDING MATTER

REQUEST: That the Traffic Engineer is requested to install speed bumps on Unit Street, Sission Street and Ortoleva Drive.

DISPOSITION: The installation of speed "HUMPS" not bumps is one type of traffic calming measure. A comprehensive study would be required before any measures are taken. Presently, there is a section in the Elmwood neighborhood that has implemented traffic calming and the Fox Point neighborhood is presently being studied. The above area will be studied next.
