Be it ordained by the City of Providence:

SECTION 1. Chapter 1489 of the Ordinances of the City of Providence, as approved September 21, 1962 entitled "An Ordinance Making Appropriation of \$43,334,668.75 for the Support of the City Government for the Fiscal Year Ending September 30, 1963" is hereby amended by appropriating the sum of One Hundred Four Thousand (\$104,000) Dollars to Fire Department, Item 0 and Seven Thousand Five Hundred (\$7,500) Dollars to Fire Department, Item 2.

SECTION 2. The said sum of One Hundred Eleven Thousand Five Hundred (\$111,500) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by One Hundred Eleven Thousand Five Hundred (\$111,500) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.

Chapter 1489 of the Ordinances of the City of Providence, as approved September 21, 1962 entitled "An Ordinance Making Appropriation of \$43,334,668.75 for the Support of the City Government for the Fiscal Year Ending September 30, 1963", as amended, is hereby further amended by appropriating the sum of One Hundred Eight Thousand Five Hundred Seventy-Six (\$108,576) Dollars to Police Department, Item 0 and Seven Thousand Eight Hundred Thirty (\$7,830) Dollars to Police Department, Item 2.

SECTION 2. The said sum of One Hundred Sixteen Thousand Four Hundred and Six (\$116,406) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by One Hundred Sixteen Thousand Four Hundred and Six (\$116,406) Dollars.







No. 612 AN ORDINANCE AMENDING SECTION 43.1 AND 43.2 OF  
CHAPTER 2 OF THE 1946 REVISED ORDINANCES, ENTITLED  
"ADMINISTRATION", AS AMENDED.

Approved December 7, 1962

Be it ordained by the City of Providence:

SECTION 1. The last paragraph of Section 43.1 of Article III of Chapter 2 of the 1946 Revised Ordinances, as amended, is hereby further amended to read as follows: Subsequent to his first full year of service, each fireman shall be entitled to receive sixty dollars each year; provided, however, that each fireman regularly required to wear dress uniform during his hours of duty shall be entitled to receive ninety dollars each year. Said sums shall be paid at such times and upon such terms and conditions as may be prescribed by rule or regulation adopted by Commissioner of Public Safety and approved by the City Controller.

SECTION 2. The last paragraph of Section 43.2 of Article III of Chapter 2 of the 1946 Revised Ordinances, as amended, is hereby further amended to read as follows: Subsequent to his first full year of service each uniformed police officer, detective and police driver shall be entitled to receive ninety dollars each year to be paid at such times and upon such terms and conditions as may be prescribed by rule or regulation to be adopted by Commissioner of Public Safety with the approval of the City Controller.

SECTION 3. This Ordinance shall take effect and become operative as of October 1, 1962.
