SUBJECT: Referral No. 1342 - ZONING CHANGE AT 32 TO 40 WOONASQUATUCKET AVENUE

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, October 1, 1963.

This referral is a request for a change in zoning from R-2 to C-1 Lots 69 and 845 on Assessor's Plat 80. Said lots are located on the southwesterly side of Woonasquatucket Avenue at the intersection of Josephine Street (Bel Air Drive). The area in question contains 16,073 square feet of land.

An inspection and photographic survey determined the lots in question to contain one vacant 2½-story 1-family frame dwelling and a two-stall two-story frame carriage house. The surrounding area is primarily one of one-family dwelling units of which several have just been constructed.

A previous referral, numbered 1215 and dated July 26, 1961, from the Committee on Public Works, concerned approval of a plat bordering on Woonasquatucket Avenue, Josephine Street and Woonasquatucket River. The City Plan Commission recommended denial; the petition was granted.

It is felt that the granting of this petition would be a flagrant use of spot zoning, and as more than adequate commercial zoning exists in the vicinity along Manton Avenue,


