Cianci, Jr., Mayor of the City of Providence has pursuant to Section 3.11 of the Charter of the City of Providence, Rhode Island, requested the City Clerk in writing, to Call a Special Meeting of the City Council to be held on the 12th day of March, A.D., 1981, at 8:00 o'clock P.M. (E.S.T.) for the Purpose of Enacting the Following:

An Ordinance authorizing the Assessment and Collection of a Supplemental 1980 Tax in a Sum Not Less than Fourteen Million, Three Hundred Ninety-Nine Thousand, Six Hundred, Ninety-Six Dollars (\$14,399,696.00) and Not More than Sixteen Million, Five Hundred Thousand Dollars (\$16,500,000.00) being based on One Hundred Percent (100%) of the 1980-1981 Fiscal Year Tax Collection.

An Ordinance Making an Appropriation of One Hundred Thirty Nine Million, Three Hundred Sixty Four Thousand Eight Hundred Seventy Six Dollars (\$139,364,876.00) for the Fiscal Year Ending June 30, 1981.

An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees in Certain Classes in the City Departments and Repealing Ordinance Chapter 1980-5 Approved March 14, 1980, as Amended.

An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Chapter 1980-6 Approved March 14, 1980, as Amended.

You are therefore, hereby commanded and required to summon each Member of the City Council to that Special Meeting as Called.
