As a current school board member, main objective is to see the push for educational reform is followed through with. As a parent of 3 school age children, my original concern was to enhance the educational experience for all Providence Students. That needs to be achieved through consistency, fortitude, compassion and hard-work. The strengths I bring to this position are a strong belief that reform is achievable, 3 years of School Board experience, 4 years as a Child advocate, Strong Parent involvement in my children's education, expertise in the field of special education, an understanding of city, state and federal movements on education.

The most critical issue facing the Providence School System is the way the state currently funds education. We need to achieve our goal of Guaranteed Student Entitlement to ensure an equitable system for all children. Other issues that impact our children are teacher's union contract, stronger parent involvement, need of choice programs for all children, bussing for choice and not for seat availability, more involvement needed by the community at-large, insuring that the PROBE recommendations be implemented and are successful, higher expectation & standards are needed for both students and teachers, lowering of the drop-out rate, making schools more accessible to all, need for ~~sensitivity~~ <sup>sensitivity</sup> to all students, and a need to instill the belief that ALL children can truly learn.
