RESOLVED (1) That the City Council urge the passage by the General Assembly of that Act entitled:



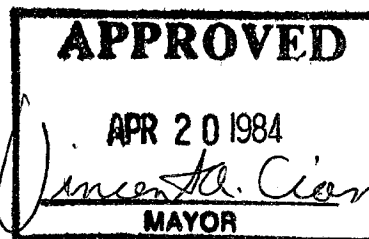
which provides that Workers' Compensation benefits from the City of Providence be reduced by any retirement or disability benefits to which that employee is entitled.

It is enacted by the General Assembly as follows:

1 SECTION 1. Section II of Chapter 489 of the Public Laws
2 of 1923 entitled "An Act to Provide for the Retirement of
3 Employees of the City of Providence, as amended," is hereby
4 further amended to read as follows:

5 SECTION 2. Pensions Offset by Compensation Benefits:
6 Workers' Compensation. Any member receiving or eligible to
7 receive retirement or disability benefits herein shall not be
8 eligible to receive Workers' Compensation benefits from the
9 City of Providence. Any amounts paid or payable under the
10 provisions of any action for damages for personal injuries
11 against the City of Providence, on account of death or disability
12 of a member, shall be offset against and payable in lieu of any
13 benefits payable out of funds provided by the City of Providence
14 under the provisions of this Act on account of the death or
15 disability of the member. If the value of the total commuted

1 benefits under any such workers' compensation law or action is
2 less than the pension reserve on the benefits otherwise payable
3 by the City of Providence under this Act, the value of the
4 commuted payments shall be deducted from the pension reserve
5 and such benefits as may be provided by the pension reserve so
6 reduced shall be payable under the provisions of this Act.

OF

AN ACT

IN AMENDMENT OF SECTION II OF CHAPTER 489 OF THE PUBLIC
