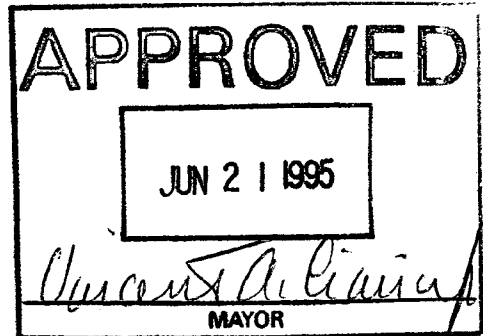

RE: TRANSMITTAL OF COMMUNICATION TO COMMITTEE

REQUEST: That the Traffic Engineer is requested to cause the installation of 3-way stop signs at the intersection of Grove Street and Almy Street.

DISPOSITION: Denied. This intersection does not meet the warrants for a multi-way stop control. From 1989 thru May 18, 1995, there have been only six reported accidents. The minimum warrant is five in one calander year.
