ORDINANCES SECOND READING

The Following Ordinances were in City Council October 7, 1976, Read and Passed the First Time, and Are Returned for Passage the Second Time:

An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Chapter 1976-11, Approved April 13, 1976, as Amended, and as Further Amended.

Be it ordained by the City of Providence:

Section 1. The following Compensation Plan

is hereby adopted as the official Compensation Plan for all City Officials and Workers Services and shall be applied to positions in the service as hereinafter provided. Each salaried position is placed in one of thirty-five "Pay Grades" each of which contains five "Steps" in order to provide for periodic increases. The "Pay Grades," "Steps" and "Annual Range" totals are recorded herein. All other salaries paid to City Officials and employees not in above pay grades shall be specifically specified.

Sec. 2. The minimum rate of pay for any class of position shall be payable to any person on his first appointment to the position allocated to the class, provided however, that with the recommendation of the Director of Finance and approval of the Mayor, he may enter the position at any other step in the "Pay Grade" and provided further, that if a person already in the service is transferred, he may with the recommendation of the Director of Finance and approval of the Mayor, enter the new position at the same rate of pay as he had previously received.

Sec. 3. Any employees employed in a position allocated to a class carrying minimum and maximum pay rates may be granted a pay increase from one step to the next higher step within established grade, subject to the following:

1. One "Pay Grade" step per year.

2. Recommendations for step increases shall be made by department heads or the Chairman of Bureaus or Commissioners at the time of submission of annual budget estimates, and at no other time. Such recommendations shall be made on the basis of the quality of work and the seniority of individual employees.

3. The Director of Finance shall review such proposed step increases for availability of funds and conformity to the provisions of this Ordinance.

ance, and shall recommend approval or disapproval of the increase to the Mayor.

4. An employee entering the city service shall be eligible for a step increase on the first day of the succeeding January, April, July or October next following the completion of twelve months of service by said employee in accordance with the provisions of sub-sections 1, 2, 3, and 5 of this Section.

5. Any employee who is transferred from a position not carrying a minimum and maximum pay rate to one that carries a minimum and maximum pay rate shall receive either his present salary or the minimum salary of the new position, whichever is greater, but in no case shall the new salary exceed the maximum salary of his new position.

6. Increased compensation received by an individual as the result of promotion from a lower to a higher class shall not be deemed a step increase in the sense of the term as used in this section and in the event of promotion shall automatically receive the minimum salary for the class to which he has been promoted. If such minimum salary is the same or less than the salary he received prior to his promotion, he may receive a salary which shall be one full increment higher than his prior salary, but in no case to exceed the maximum.

Sec. 4. A given rate of pay as expressed in the compensation plan may be commuted to weekly, daily or hourly rate and established by a department head or Chairman of a Bureau or Commission with the approval of the Mayor and the Director of Finance, as the rate of pay for employees of a particular class: provided, however, that all employees of a given class in a given unit of a department shall be paid on the same basis, excepting part-time and temporary employees.

Sec. 5 No Officer or employee of the City shall issue a check for payment of, or pay any salary or compensation to any person holding, or claiming to hold a position in the classified service, unless the Personnel Director shall have first

certified that the persons named on the payroll or account of such compensation have been appointed and are employed in accordance with this Ordinance.

Sec. 6. Chapter 1976-11 of the Ordinance approved April 13, 1976 with all amendments thereto is hereby repealed.

Sec. 7. This Ordinance shall take effect upon its passage, retroactive to July 1, 1976.

An Ordinance in Amendment of Chapter 18 of the Code of Ordinances of the City of Providence, Rhode Island, Creating a Department of Public Parks and Eliminating the Division of Public Lands within the Department of Public Property.

Be it Ordained by the City of Providence:

Section 1. Creation of Department. 18-40 pursuant to the provisions of Chapter 104 of the Public Laws of Rhode Island, 1963, there is hereby created in the City of Providence, a Department of Public Parks. The Division of Public Lands and Parks of the Department of Public Property is hereby eliminated.

Sec. 2. 18-41 Jurisdiction. The Department

of Public Parks shall be responsible subject to the authority of the Board of Park Commissioners as established in Article VI of the City Charter, for all public parks and for all structures and facilities located therein including the zoo and museum located in Roger Williams Park, for all municipal burial grounds and for all structures and facilities located therein and for all street trees within the City of Providence. It shall be responsible for the administration, planning, design, construction, planting alterations, maintenance, operations and repairs to the same. No other city department, board, bureau, commission or other agency whatsoever may undertake any plan, activity, construction or operation in or involving any public park of the city except by permission of the Board of Park Commissioners.

Sec. 3. 18-42 Staff and Organization. The Department of Public Parks shall be headed by the Superintendent of Parks who shall be appointed by the Board of Park Commissioners and who shall have the status of a department head with all the powers and duties appertaining thereto, shall be subject to all provisions of the City Charter relating to department heads, and shall take an oath of office as provided in Section 4.4 of the City Charter. The Department of Public Parks shall consist of five divisions. The heads of each division shall be appointed by the Superintendent and will be subordinate to the Superintendent of Parks.

1. The Division of Parks which shall be headed by the Deputy Superintendent of Parks.
2. The Division of Burial Grounds which shall be headed by the Superintendent of the North Burial Ground.
3. The Zoo Division which shall be headed by the Director of the Roger Williams Park Zoo.
4. The Division of Forestry which shall be headed by the City Forester.
5. The Museum Division which shall be headed by the Director of the Roger Williams Park Museum.

In addition to the heads of divisions, the Superintendent of Parks will be assisted by such assistant superintendents and other employees as may be authorized for the Department of Public Parks under ordinances previously or hereafter enacted.

Sec. 4. 18-43 Purchasing. It is hereby prescribed that in an open, public, equitable and competitive manner, the Department of Public Parks shall select the vendor and negotiate the price and terms of any procurement for the Department of Public Parks of value less than the amount set by law for procurement through the Board of Contract and Supply. Authorization for payment of such purchases issued by the Department of Public Parks shall be paid within thirty days by the City Controller up to the total amount appropriated in the city budget for the operation of the Department.

Sec. 5. 18-44 Fiscal Affairs. No funds appropriated to the Department of Public Parks or income from trust funds donated to the city for the facilities or programs thereof or income derived from the sale of surplus property belonging to the Department of Public Parks may be transferred to or used to pay the bills of any other city department, board, bureau, commission or other agency whatsoever, nor may any personnel paid from funds appropriated to the Department of Public Parks be transferred to or assigned to work on any program or project whatsoever of any other city department, board, bureau, commission or other agency whatsoever without the express written permission of the Superintendent, subject to the approval by the Board of Park Commissioners. No expenditure shall be made by the City Controller or by any other city employee of any funds appropriated to or trust funds donated for the facilities or programs of the Department of Public Parks except upon written authorization of the Superintendent of Parks the Board of Park Commissioners. No park land, structure, or facility may be transferred to any other city department, board, bureau, commission or other agency whatsoever without the consent of the Board of Park Commissioners.

Sec. 6. 18-45 Effects of Conflict. In any case

where the provisions of this ordinance or of any regulation issued by the Superintendent of Parks or the Board of Park Commissioners under Section 4.25 of the City Charter pursuant to this ordinance is found to be in conflict with the provisions of any ordinance, resolution, rule or regulation of the City of Providence other than the City Charter, the provisions of this ordinance shall apply except that nothing herein shall be construed to abolish, affect or in any way reduce or diminish any of the powers heretofore granted by Charter and Ordinance to the Board of Park Commissioners.

Sec. 7. This Ordinance shall take effect upon passage.

PERSONAL PRIVILEGE

COUNCILMAN GORODETSKY requests and is granted the Privilege of the Floor referring to that matter on this day's Council Docket concerning the appointment of a Sub-Committee to Undertake a Study of the Reapportionment of Ward Lines stating that he would be remiss in his obligation, and that he owes it to himself, as a human being to speak to that subject noting that the Committee on Ordinances has transmitted a communication to the City Council of a Sub-Committee being named, which Committee, he believes, has no authority to make these appointments, an item, such as Reapportionment which is important to all in the City, especially the Members of the City Council, and that there are more than adequate people serving on this Council to handle matters like this; that he feels that appointments such as himself, one who is not overworked, being on a solitary Committee Assignment and that particularly he has plenty of time available and possessing a considerable amount of expertise in Municipal Government, in many phases of it; he is disappointed that under

the guise of getting help that Members of this Council had to go outside of the Membership of the City Council to get help, further stating that as always, his remarks are directed with sincerity and integrity as a political representative of this City.

COUNCILMAN AHERN requests and is granted the Privilege of the Floor and extends to his youthful colleague Thomas M. Glavin a most hearty welcome and states that he succeeds, to a Council Seat in the Twelfth Ward, a long list of some most capable and respected men and that his addition will bring to the Council, youthful sagacity and a desire to be of service to the Twelfth Ward Constituency, and further wishing him good health, success and good judgment in his deliberations.

He further states that his new colleague was referred to sometime ago as "a 23 year old puppet," but he is far from being a puppet, and that he (Ahern) was referred to as a "has-been" al-

though he has been in politics for over 45 years, as a true Democrat, and will remain as such until his passing.
