RESOLUTION OF THE CITY COUNCIL

No. 170

Approved March 26, 1981

WHEREAS, Over recent years a number of amendments to the public laws of the State of Rhode Island establishing and governing the Employees Retirement System of the City of Providence have been enacted by the General Assembly; and

WHEREAS, Many of said amendments have improved retirement benefits for members of said System with resulting increases in the financial burden to be borne by the taxpayers of the City of Providence; and

WHEREAS, The City of Providence is in dire financial circumstances and must take all reasonable measures to ease the tax burden on Providence taxpayers,

NOW, THEREFORE BE IT RESOLVED, THAT

1. The General Assembly is hereby requested by the City of Providence not to enact any further laws or amendments to the 1923 Public Laws establishing the Employees Retirement System of the City of Providence improving the benefits payable to members of said System until further contrary action of the Providence City Council, and

2. That upon passage of this Resolution the City Clerk is requested to forthwith forward copies of this Resolution to the Governor of the State of Rhode Island, the leaders of the majority and minority parties of the House of Representatives and the Senate and such other legislative leaders or members as she may in her discretion deem appropriate.


