## RESOLUTION AUTHORIZING CONVEYANCE OF LAND.

WHEREAS, the City Council by Resolution No. 177, approved March 29, 1985, authorized his Honor the Mayor to execute an agreement, on behalf of the City of Providence, with the State of Rhode Island regarding the Memorial Boulevard Extension Project, and including the relocation of the Moshassuck and Woonasquacket Rivers, traffic improvement, and other matters relative to said property; and

WHEREAS, pursuant to said resolution the City of Providence by his Honor the Mayor on January 16, 1987, executed an agreement with the State of Rhode Island entitled "Providence River Relocation - Memorial Boulevard Extension Project Comprehensive Agreement," and...

WHEREAS, pursuant to said agreement the City of Providence is to convey Parcel 2F in said project (6240 sq. ft.) in return for a portion of Parcel 2G in said Project (7002 sq. ft.), said Parcels appearing on State Condemnation Plat No. 2128 filed in the Providence Land Records on November 13, 1987.

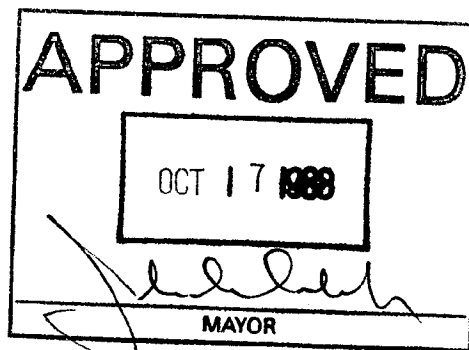
NOW, THEREFORE, IT IS RESOLVED: That his Honor the Mayor is authorized to convey to Capital Properties, Inc. Parcel 2F on Sheet 1 of 2 on State Condemnation Plat No. 2128 filed in the Providence Land Evidence Records on November 13, 1987, the City being authorized to make said conveyance pursuant to Rhode Island General Laws Section 45-24.4-21, and the execution of the conveyance by his Honor the Mayor on August 2, 1988, is hereby ratified, confirmed, and approved.
