WHEREAS, Monsignor John Patrick Carroll-Abbing, Dublin, Ireland, Irish born citizen and since 1930 a most welcome and venerated resident of Italy, has devoted and continues to devote his God given inspiration to the further development of Boys' Towns of Italy, which he founded, with Don Antonio Revolta, a Milanese priest, on June 5, 1945 and which has been augmented by nine additional such towns, a Girls' Town and thirty Nursing and Day Care Centers dedicated to provide housing and education for orphaned and abandoned children, and

WHEREAS, Monsignor Carroll-Abbing's program to save Italian youngsters from misery and Communism attracted International good will and assistance from such groups as Amalgamated Clothing Workers' Union; Food Industry of America and people of various national origins and of different religious faiths; the Italian government which bestowed upon this small spritely priest, its Silver Medal for Military Valor during the Nazi occupation of Italy; from former King Umberto of Italy, the Order of Saints Maurice and Lazarus and, ironically from the Communist Mayor of Genzano, who granted him freedom of that City, its citizenship.

NOW THEREFORE BE IT RESOLVED, That in consideration of this Internationally recognized program, the one-time President of the Medical Commission in the National Agency for Distribution of Relief and of his zeal for People-Helping-People Program, His Honor Walter H. Reynolds, Mayor of the City of Providence, Rhode Island, United States of America, and the Members of the Governing Body being the City Council thereof do collectively and individually wholeheartedly endorse the charitable endeavors of Monsignor John Patrick Carroll-Abbing, founder of Boys' Towns of Italy, and

BE IT FURTHER RESOLVED, That a duly engrossed copy of this manifestation be forwarded to Monsignor Carroll-Abbing.
