No. 604 **AN ORDINANCE** IN AMENDMENT OF CHAPTER 544 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED "AN ORDINANCE ZONING THE CITY OF PROVIDENCE AND ESTABLISHING USE, HEIGHT, AND AREA REGULATIONS".

Approved November 16, 1956

Be it ordained by the City of Providence:

SECTION 1. Section 71, of Chapter 544 of the Ordinances of the City of Providence, entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height, and Area Regulations" as amended, is hereby further amended as follows:

Sec. 71 B entitled "Public Utilities and Public Services" is amended to read as follows:

B. Public Utilities and Public Services.

The provisions of this Ordinance shall not be construed as to limit or interfere with the construction, installation, operation, and maintenance for public utility purposes, of water and gas pipes, mains and conduits, electric light and electric power transmission and distribution lines, telephone and telegraph lines, oil pipe lines, sewer mains, and incidental appurtenances, and public telephone booths in C and M Zones, provided that corner setbacks requirements as set forth in Section 26-A-5 are complied with in respect to such booths.

SEC. 2. This Ordinance shall take effect upon its passage.

SUBJECT: REFERRAL NO. 842 - AMENDMENT TO THE ZONING ORDINANCE OF SECTION 71B OF CHAPTER 544

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, August 21, 1956.

This referral is a request for the following amendment of Chapter 544 of the Ordinances of the City of Providence, entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations".


Section 71B entitled "Public Utilities and Public Services" is amended to read as follows:

The provisions of this Ordinance shall not be construed as to limit or interfere with the construction, installation, operation and maintenance for public utility purposes, of water and gas pipes, mains and conduits, electric light and electric power transmission and distribution lines, telephone and telegraph lines, public telephone booths in M and C zones, oil pipe lines, sewer mains and incidental appurtenances.

The amendment as proposed would remove the requirement for setting structures back 12 feet from the curb and also for the 15 foot corner setback. While the curb setback is not overly important it is strongly felt that the corner setback for vision clearance is essential for public safety.

The Commission

VOTED: To offer no objection to the amendment if it is changed to read "public telephone booths in M and C zones, (provided that corner setback as required by Section 26-A-5 is provided".)


Dear Mr. Whelan:


