No. 650 AN ORDINANCE IN AMENDMENT OF THE CODE OF ORDINANCES--CITY OF PROVIDENCE, RHODE ISLAND, CHAPTER 18, SECTION 18-51 OF THE CODE ENTITLED "APPOINTMENT, TERM OF DIRECTOR OF RECREATION," AND CHAPTER 18, SECTION 18-54, ENTITLED "DEPUTIES, ASSISTANTS AND EMPLOYEES OF DEPARTMENT OF RECREATION."

Approved December 20, 1974

Be it ordained by the City of Providence:

SECTION 1. Chapter 18, Section 18-51 of the Code of Ordinances--City of Providence, Rhode Island, entitled "Appointment, Term of Director of Recreation" is hereby amended to read as follows:

"Sec. 18--51. Appointment, Term of Director of Recreation.

The Mayor shall appoint, subject to the approval of the Council, a qualified person to serve as director of recreation. Said director shall hold office until the first Monday in January, 1972, or until his successor is elected and qualified. On the first Monday in January, 1972, or soon thereafter as may be convenient, and every fifth year thereafter, the Mayor shall appoint said director for a term of five (5) years. Any vacancy occurring in the office of director of recreation shall be filled in like manner by appointment by the Mayor, subject to the approval of the Council."

SEC. 2. Chapter 18, Section 18-54 of the Code of Ordinances--City of Providence, Rhode Island, entitled "Deputies, Assistants and Employees of Department of Recreation" is hereby amended to read as follows:

"Sec. 18-54. Deputies, Assistants and Employees of Department of Recreation.

The Director of Recreation shall appoint such deputies, assistants and employees under his supervision and control as the city council may deem necessary and for whose compensation appropriation has been made. The city council shall prescribe their powers and duties, fix their compensation and establish their classification."

SEC. 3. This Ordinance shall take effect upon its passage, and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.
