No. 683 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE, CHAPTER 1981-39, EFFECTIVE JULY 20, 1981, BY TRANSFERRING THE SUM OF THIRTEEN THOUSAND, SIX HUNDRED FORTY DOLLARS (\$13,640.00) FROM ENGINEERING ITEM 001, TO SEWER CONSTRUCTION AND MAINTENANCE ITEM 001.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1981-39 of the Ordinances of the City of Providence, effective July 20, 1981, entitled: "An Ordinance Making an Appropriation of One Hundred Forty-Nine Million, Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars and Nine Cents (\$149,862,122.09) for the Fiscal Year Ended June 30, 1982", is hereby amended by transferring the sum of Thirteen Thousand, Six Hundred Forty Dollars (\$13,640.00) from Engineering Item 001, to Sewer Construction and Maintenance Item 001.

SECTION 2. This Ordinance shall take effect upon its Passage.



REASON: Adjustments in Appropriation Ordinance

The transfer of \$4,000 from Item I to Item "0" within the Building Board of Review is to pay for part-time help in the department as per agreement between the department head and the Finance Committee at the budget hearings; the transfer of \$1,330.00 from Item I to Item "0" within the Zoning Board of Review is to pay for a classification change which was not in the budget.

The transfer from purchasing to Public Buildings of \$44,843.52 is to pay for a rent omitted from the original Ordinance during the reorganization of Public Works, the money is anticipated savings in the motor fuel account.

The transfer of funds within Public works from Engineering Item "0" of \$13,640.00 to Sewer Construction Item "0" is to pay the salary of an employee transferred within these departments.
