An Ordinance in Amendment of the Appropriation Ordinance Chapter 1977-35, Approved July 18, 1977, by Appropriating a Sum Not to Exceed Two Thousand Dollars (\$2,000.00) to Soldiers' Burial Account, 1-14-07.

Be it ordained by the City of Providence:

Section 1. Chapter 1977-35 of the Ordinances of the City of Providence, as approved July 18, 1977, entitled: "An Ordinance Making Appropriation of \$108,255,372.79 for the support of the City Government for the Fiscal Period beginning July 1, 1977, and ending June 30, 1978, is hereby amended by appropriating the sum of Two Thousand Dollars (\$2,000.00) to the City of Providence Account — Soldiers Burials, Item 3.

Sec. 2. The said sum of Two Thousand Dollars (\$2,000.00) as thus added and appropriated

shall be obtained by authorizing the City Controller and City Treasurer to transfer a like sum from funds not otherwise appropriated.

Sec. 3. This Ordinance shall take effect upon its passage.

COUNCILMAN BRADSHAW and COUNCILMAN PEARLMAN:

Resolution Commending the Students of Brown University for Their Untiring Assistance to the Red Cross in Their "Operation Ski Out."

Whereas, As a result of the severe snow storm of Monday, February 6, 1978, Citizens throughout the City of Providence were in need of food for the various shelters which were afforded them, and

Whereas, The Red Cross Chapter located on Waterman Street, being in need of assistance for persons to travel with skis to the various shelter locations, asked for this assistance through the News Media who in turn immediately broadcast the request, and

Whereas, Students of Brown University came forth with such enthusiasm, a waiting list was formed and the Red Cross Chapter planned their "Operation Ski Out," and

Whereas, Red Cross found it feasible to feed thousands of people when the students backpacked sufficient food to the various shelters and homes of elderly and ill people stranded without food, and

Whereas, During this crisis, as many as Five Thousand People were fed Three meals a day, which were provided by Army National Guard Air Helicopters and backpacked by Brown University Student Volunteers to the numerous shelters,

Now, Therefore, be it Resolved, That the City Council of the City of Providence extends their appreciation and commendation to the many students of Brown University who willingly gave their assistance to aid the Red Cross Chapter to feed thousands of people stranded at the various shelters and homes throughout the City of Providence, during this crisis.

Whereas, The tremendous snow storm of February 6, 1978 has been the subject of much controversy regarding the City's response to meet this natural disaster, and

Whereas, It has taken the City a week from the date of said snow storm to adequately clear the business and residential sections within the downtown section of the City of Providence,

Now, Therefore, be it Resolved, That the Committee on Public Works be authorized to conduct an indepth investigation, including powers to subpoena persons and records, pertaining to a complete investigation into the snow removal element.

COUNCILMAN GARAN:

Resolution Commending All City Workers for Their Extended Efforts During the Recent Emergency Condition Which Existed During the Week Which Resulted from the Snow Storm of February 6, 1978.

Whereas, The City of Providence was besieged with the worst snow storm in many decades, and

Whereas, The Administration had no preconceived plan that could be put into effect upon blizzard conditions, and

Whereas, Our City Employees, together with Policemen and Firefighters were subjected to many pressures arising from emergency situations caused by people who were without food, fuel, shelter, medical care and the many Citizens having been stranded in their automobiles, and

Whereas, The City Workers had to contend with inadequate equipment and an insufficient amount of equipment to combat the blizzard, and

Whereas, Said City Workers received outside interference in the operation of the Public Works Department, and were subjected to conflicting directiveness from several different sources which deterred their effort in efficient snow removal, and

Whereas, The entire snow removal operation was utilized as a Political "Football" between City Hall and the State House, and

Whereas, The Mayor failed to impose the parking ban early enough and to dismiss City Employees early enough on the day of the storm thereby causing a traffic jam which made Streets impassible for plowing, and

Whereas, In spite of all the foregoing obstacles which City Workers were confronted with in the performance of their duties, many unselfish acts of heroism were performed by the said Workers to assist the people of the City of Providence in their plight, they having worked long hours without sleep and rest during this crisis,

Now, Therefore, be it Resolved, That the City Council hereby commends all City Workers in the City of Providence for making the best out of a very difficult situation.

PERSONAL PRIVILEGES

Mr. President and Members of the City Council. In the Providence Journal there was an article which stated an anonymous caller had informed that a Storage Shed on Ralph Street was cleared of snow which is owned by Councilman Stravato. I assisted in the coordination of snow removal in the Seventh Ward together with Councilman Almagno and I do not own a Storage Shed on Ralph Street. Ralph Street was cleared Sunday afternoon. I take personal offense to that statement as Councilman Almagno and myself worked very hard on this snow removal.

Further, I would like to make another point. I noticed that many of our schools do not have the exits cleared of snow which could be a disaster if a fire occurred. At least exits and fire exits should be cleared of all snow as this could be hazardous. A special memorandum should be sent to the Superintendent of Schools requesting the removal of snow at said exits.

cause like Councilman Stravato said, I too had been made a victim of big happenings. My brother, Councilman Flynn, for whatever reason I do not know, during the storm decided to speak to the press that Councilman Mansolillo's Street, which is Moore Street, was plowed. That is all he said. However, these kind of things in that type of a crisis, suggest politics as said earlier. Just to set the record straight, as to what happened at that point, none of us had indication as to what could be plowed, Moore Street was plowed on Wednesday Evening or early Thursday morning about 4:00 o'clock A.M. and that is because a City Communication Truck was stranded on Updike Street which is near Moore Street. It is regrettable these kind of things bring out the best, as well as the worst, in thinking that comes out of us all. It is unfortunate that these exchanges are necessary, particularly when information that is being used to make those ascertions are not complete. Like Councilman Stravato, being victimized by a brother Councilman, I was upset. I hope all of us take a lesson from this storm and learn that Political Statements during this kind of crisis serve no purpose.
