No. 331 **AN ORDINANCE** IN AMENDMENT OF THE APPROPRIATION ORDINANCE CHAPTER 1976-9, APPROVED APRIL 13, 1976, BY APPROPRIATING A SUM NOT TO EXCEED THIRTY FIVE THOUSAND (\$35,000.00) DOLLARS, TO PROVIDENCE COMMUNITY MENTAL HEALTH (13-06).

Approved June 27, 1976

Be it ordained by the City of Providence:

SECTION 1. Chapter 1976-9 of the Ordinances of the City of Providence, as approved April 13, 1976 entitled: "An Ordinance Making Appropriation of \$94,535,771.00 for the support of City Government for the Fiscal Period beginning July 1, 1975 and ending June 30, 1976 as amended is hereby further amended by appropriating the sum of Thirty Five Thousand Dollars (\$35,000.00) to the Community Mental Health Center Item 3.

SECTION 2. The said sum of Thirty Five Thousand (\$35,000.00) Dollars as thus added and appropriated shall be obtained by authorizing the City Controller and City Treasurer to transfer Thirty Five Thousand (\$35,000.00) Dollars from the Reserve Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated Receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Thirty Five Thousand (\$35,000.00) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.
