Whereas, Corporal Joseph R. Tria, a native of this City, the son of Joseph and Chiara (Composeo) Tria, paid the supreme sacrifice on June 1, 1953 as the result of enemy action in the Korean Campaign, and

WHEREAS, this courageous Squad Leader of a heavy Mortar Company of the 14th Infantry Regiment, 25th Division, had repeatedly distinguished himself in the service of his country, and

WHEREAS, in order to perpetuate the memory of this gallant member of the United States Army, his relatives and many friends have requested a square be dedicated in his honor and memory,

NOW, THEREFORE, BE IT RESOLVED, that the intersection of Academy Avenue and Eaton Street be and it is hereby designated as, "Corporal Joseph R. Tria Memorial Square" as follows:

Beginning at the northwesterly corner of Academy Avenue and Eaton Street; thence easterly and crossing Academy Avenue to the northeasterly corner of Academy Avenue and Eaton Street; thence southerly and crossing Eaton Street to the southeasterly corner of Academy Avenue and Eaton Street; thence westerly crossing Academy Avenue to the southwesterly corner of Academy Avenue and Eaton Street; thence northerly and crossing Eaton Street to the northwesterly corner of Academy Avenue and Eaton Street and the point and place of beginning; provided, however, that nothing herein contained shall be construed to change the designation of Academy Avenue or Eaton Street which are hereby declared to continue in and through the said designated area.
