WHEREAS, Blighted and foreclosed homes are having a severe and adverse impact on many city neighborhoods; and

WHEREAS, The blighted and foreclosed home at 58 Candace Street, Assessor's Plat 69, Lot 531, is part of the neighborhood's development plan to rehabilitate blighted and foreclosed homes in the Smith Hill neighborhood; and


WHEREAS, The Department of Housing and Urban Development has offered to sell the blighted and foreclosed home at 58 Candace Street, Assessor's Plat 69, Lot 531, to the City of Providence for the sum of One Dollar (\$1.00).

NOW, THEREFORE, BE IT RESOLVED, That the Mayor, or his designee, is hereby authorized to enter into a sales contract agreement with the Department of Housing and Urban Development to purchase the foreclosed property located at 58 Candace Street, Assessor's Plat 69, Lot 531, for the sum of One Dollar (1.00) for immediate transfer to the Providence Redevelopment Agency, for the redevelopment purposes and that the property is declared exempt in accordance with Rhode Island General Law 45-2-40 while under PRA ownership.


