SECTION 1. Chapter 1788 of the Ordinances of the City of Providence as approved September 26, 1966, and entitled: "An Ordinance Making Appropriation of \$47,405,335.25 for the Support of the City Government for the Fiscal Year Ending September 30, 1967", as amended, is hereby further amended by appropriating the sum of Two Hundred Fifty (\$250.00) Dollars to the DEPARTMENT OF RHODE ISLAND, ITALIAN-AMERICAN WORLD WAR VETERANS OF THE UNITED STATES, INC., CONVENTION COMMITTEE.

SECTION 2. The money hereby appropriated shall be paid to the Treasurer of the 1967 Department of Rhode Island, Italian-American World War Veterans of the United States, Inc., Convention Committee, to help defray the expenses of the Department Convention to be held in the City of Providence on June 1st, 2nd and 3rd.
