To The Honorable Joseph R. Paolino, Jr., Mayor and
The Honorable Council of the City of Providence

I hereby submit the annual report of the operations of
the Probate Court of the city of Providence for the fiscal
year beginning July 1, 1988 and ending June 30, 1989.

The cash receipts for this period amounted to \$134,478.40,
which was up from \$124,281.21 for the previous period.

In the period from July 1, 1989 to December 30, 1989 the
collections totaled \$74,841.66, which was up from \$72,664.59.

If the receipts continue as in the past I would anticipate
that the receipts for the fiscal year ending June 30, 1990 to
be around \$144,000.00.

The number of wills filed for probate this past year was
281 compared to 263 from last year, and the number of petitions
for administration was 112 as compared to 118 for the previous
year.

The number of guardianships granted by the court declined
to 77 as opposed to 88 from last year. There were 5 new petitions
for conservatorship granted during this period. There was one
adult adoption granted during this period.

There were 121 change of name petitions granted this period
as against 132 during the same period for the previous year.
In addition thereto there were 76 petitions for sale of real
estate filed by various executors, guardians and administrators.
There were also 234 miscellaneous petitions filed and granted for
various reasons.

There were 426 inventories filed by the fiduciaries and
the necessary fees collected and reflected in the total receipts
of the year.

During the year there were 237 accounts filed and processed, by guardians, Conservators, executors and administrators. There were 230 affidavits of completed administration.

There were 3 new registry accounts opened during the year totaling \$38,132.48.

All of these accounts, sales, affidavits and other petitions were processed by the staff of the court, advertised when necessary and the necessary action taken by the court during this period.

Any matters pending before the court are pending, not by reason of any delay of the court, but by failure to assign to hearing by the attorneys involved.

Although I am seriously understaffed I am fortunate in that the personnel I do have are extremely loyal and capable and permit this office to operate as efficiently as possible under the circumstances.
