RESOLVED THAT THE CITY COUNCIL:

1....Convene immediately an impartial and bi-partisan committee to investigate payroll irregularities in all City Departments as proposed by Republican Councilmen Charles A. Kilvert and Thomas W. Pearlman, May 16th, 1963 now pending in the Public Welfare Committee of the Providence City Council.

2....Request that the City Solicitor prepare for immediate enactment of an ordinance that would prohibit members of Ward and Political Committees from being City employees, a so-called "Baby-Hatch-Act".

3....Require the City Treasurer to publish and the City Controller's Office to prepare the names and addresses of all City employees each year in the personnel supplement to the annual City Budget.

4....Request the City Controller to institute a "performance audit" of every City department checking the performance and pay of all employees, work produced, the number of employees required to do the job, and time keeping records.

5....Consider for adoption at the next meeting of the City Council a three (3) member Personnel Appeal Board so that the rights of every career City employees will be protected from undue political pressure and unfair job discrimination.

6....Request the City Solicitor to prepare an ordinance for a **municipal** Civil Service system using the testing and examination facilities of the Department of personnel for the State of Rhode Island.

7....Require by ordinance all members of any Ward and Political committee resign their jobs immediately either as City employees or as members of political committees.

8....Adopt a Code of Ethics ordinance for City officials and employees to prevent City employees and officials from doing business with the City, which constitutes conflict of interest.

9....Enact an ordinance to ban "dual-office holding" so that City employees will not be permitted to serve also as members of the General Assembly, School Committee or hold other official tasks which may conflict with their City work.

10....Request the Mayor to hire a City Manager immediately subject to the approval of the City Council so that a full time career man with management experience can administrate all City departments on a business like basis.


Plat 35 Lot ~~2-3~~ 223

SUBJECT: Referral No. 1331 - ZONING CHANGE AT 1686-1700 WESTMINSTER STREET

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, June 18, 1963.

This referral is a request to change from an R-4 Zone and a C-4 Zone to an M-1 Zone Lots 222 and 223 on Assessor's Plat 35 said lots being situated on the southerly side of Westminster Street and designated as 1686-1700 Westminster Street. The area in question contains 12,000 square feet of land area.


An inspection and photographic survey determined the lots contained five frame dwellings (one, 2-story, one, two and one-half story, two, three-story, and one, four-story) with commercial uses on the first floor of the two facing the street.
