BE IT FURTHER RESOLVED, That upon the adoption of this Resolution by the City Council and its approval by His Honor the Mayor, the City Clerk is directed to transmit forthwith, a duly certified copy of the same to the Secretary of State of Rhode Island, the Rhode Island State Board of Elections, and the Board of Canvassers of the City of Providence, Rhode Island.
