

Resolved,

That His Honor the Mayor be and he hereby

is authorized to execute a Lease to Fields Point Manufacturing Corporation of a parcel of land approximately 15 feet in width and 190.51 feet in length adjoining the present area leased to said corporation; said lease to be for a period ending June 19, 1973, the rental for the period ending June 19, 1967 to be six cents (6¢) per square foot, and for the period beginning June 20, 1967 and ending June 19, 1973 to be eight cents (8¢) per square foot, with the option in the lessee to renew the Lease for an additional period of five (5) years beginning June 20, 1973, at a rental to be agreed upon between the parties, and provided further that the Lease shall contain a provision that the lessee shall agree to provide lateral support if necessary for other adjoining land of the lessor, and to contain such other terms and conditions as may be approved by the Mayor and the City Solicitor.




