Resolution Urging the Governor's Working Group to study the State Education Aid Funding Formula.

WHEREAS, The quality of the education the Providence Public Schools provides to the City's children is often limited by a lack of adequate financial resources; and

WHEREAS, The City of Providence appropriates more than \$5,000 per student in local funds to the School Department; and

WHEREAS, The City's local contribution is among the most generous in the State relative to the City's tax capacity, as measured by the "property tax effort" benchmark developed by the General Assembly at R.I.G.L. §16-7.1-6; and

WHEREAS, 2010 State aid funding formula "state share ratio" (R.I.G.L. §16-7.2-5) calculates that Providence's fair share of "core instruction expense" is approximately 12%, while the State's fair share is 88%, based on the City's relative ability to pay for education programs; and

WHEREAS, Providence's actual share of the entire "local budget" (funded by State and municipal funds) of the Providence School Department is more than 37%; and

WHEREAS, The funding gap is the result of the current formula's restrictive definition of expenditures eligible for State aid, defined as the "core instructional amount" in R.I.G.L. §16-7.2-3; and

WHEREAS, The "core instructional amount" does not include such basic expenses as transportation expense, building maintenance expense and other operating expenses; and

WHEREAS, These expenses are just as necessary to the provision of education as instructional expenses; and

WHEREAS, Despite this basic fact, the City pays for these operational expenses with 100% local funds, rather than a State/local split of 88%/12% as obtains for "core instructional expense"; and

WHEREAS, The State provides that teacher pension expense is funded 60% local/40% State, even though that expense is just as fundamental and unavoidable as those characterized as "core instruction expense"; and

WHEREAS, The great majority of funding formulas nationally provide State aid for transportation expense and/or other operating expenses in ways that Rhode Island does not; and

WHEREAS, The Rhode Island funding formula does not provide additional funding for English Language Learners, contrary to the prevailing practice in other states and contrary to a 2007 report by the General Assembly which provided for an additive weight of 0.2; and

WHEREAS, Rhode Island ranks at or near the bottom nationally of the "Nation's Report Card" for the education achievement of Hispanic students and the "achievement gap" between Hispanic and Caucasian students in each category; and

WHEREAS, A 2007 report by the General Assembly called for \$14,317 per pupil in State aid for Providence, in contrast to the 2010 funding formula's level of less than \$9,500 per pupil; and

WHEREAS, The “money follows the child” feature of the current funding formula reduces the local funds available to the children in the Providence Public Schools by millions of dollars in excess of the savings achieved by delegating to charter schools the responsibility of educating Providence students enrolled in those schools; and

WHEREAS, While marginal adjustments to the funding formula would begin to address these concerns, the current formula’s structural constraints will not provide adequate (or close to adequate) resources to support an education for Providence’s children that meets the requirements of the Basic Education Plan; and

WHEREAS, Rhode Island is one of an undistinguished minority of states that lacks an enforceable right to education under its Constitution.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council urges the Governor’s Working Group To Study The Funding Formula to recommend the passage of an enforceable right to education under the Rhode Island Constitution; and

BE IT FURTHER RESOLVED, That the Providence City Council urges the Governor’s Working Group To Study The Funding Formula to review the current formula and propose changes that would make it more fair and equitable to disadvantaged children; and

BE IT FURTHER RESOLVED, That the Providence City Council urges the Governor’s Working Group To Study The Funding Formula to recommend that the Board of Education act promptly to initiate a thorough and comprehensive study of the funding formula, including but not limited to the areas identified in the Governor’s Executive Order establishing the current working group; and

BE IT FURTHER RESOLVED, That the Providence City Council hereby urges its General Assembly delegation to advocate for a Constitutional right to education and a more fair State aid funding formula; and

BE IT FURTHER RESOLVED, That, upon passage of this Resolution, the Clerk is requested to distribute copies of it to the Providence School Board, the Providence General Assembly delegation, the Rhode Island Board of Education and the Rhode Island Department of Education and the Fair Funding Formula Working Group.

PERSONAL EXPRESSION

COUNCILMAN NARDUCCI Requests the privilege of the floor to speak on a Point of Personal Expression and states:

“First of all, I would like to thank each and every one of my colleagues for supporting me and my family through a very, very tough time. When you have something like this happen, you don’t realize how lucky you are even though something like this happens, until we see other situations people are in. We are very proud to live in the 4th Ward because in the 4th Ward it’s the fighting 4th Ward, you can’t keep us down because we will get back up and fight. We were able to still feed eighty families at Thanksgiving thanks to my daughter. Again, thanks to my colleagues for coming and helping me out. We take so much in life for granted. There was a time where most of you know because you saw when I first took my stroke that I couldn’t even get up and go to the bathroom by myself. I couldn’t get out of bed, I couldn’t move my arm at all. It’s the little things now that are so important to me. I’m just going to say and I know sometimes you have to be careful what you say, but when a man goes to the bathroom a man stands up, I never thought I would be so happy to stand up and go to the bathroom again. It was a great feeling. If it wasn’t for my family and friends and the outpouring of support, every single person asking the same question and we all do it. Anything you need call, is there anything I can do for you, we will be there. I said yes, one thing everybody can do for me is just pray, not just for me but for my family. I went to rehabilitation. I had a goal, a major goal and that was to walk my little girl down the aisle for her wedding and do the father daughter dance. I know most of you have seen it because I know she put it on Facebook. Not only did I walk her down that aisle, but I danced the whole father daughter dance with her all six minutes. My therapist came in on a Wednesday and I got settle in. They said what are you doing? I said look the nurses just got done doing my administration papers. I just said I am just relaxing for now. They said no you’re not. We heard we you have ten days to get your daughter down that aisle and they were fantastic, Rhode Island Rehabilitation. For those of you that don’t know where it is, it’s in North Smithfield, Rhode Island. They are the best, I sent a letter to the Governor telling her that we should be very proud to have that organization here in the State of Rhode Island because what they did for me and what they do for the families that

rely on them day in and day out while you are there it's totally incredible. So, to get to the end of things I went to my neurologist Friday and he said I think it's a good idea if we start getting back to somewhat of a normal life. He said well it's not challenging. I said I have a good way I can start doing that Thursday night and he said what's that? I said I can go see my colleagues down at City Hall and start getting back into the City Hall business. So, here we are and again, I just want you all to know how much I appreciate everybody's thoughts and prayers. I do want to tell you one quick thing. One day I am sitting in the hospital bed and there were an overabundance of fruit baskets, plants and cards and I was so glad to get the cards that I got because when you're lying in that bed and you're just looking forward to going to therapy the next morning for four to five hours and then you're back in bed, there is nothing like being able to sit there literally looking at these cards and reading all the stuff that people write in them. I had so many of my constituents send us cards and give us phone calls and like I said it was just a beautiful outpouring of support. Again, when we have a crisis and we see that no matter what our beliefs are and where we come from, the bottom line is no matter what God you believe in or what God you think is God, there is a God. There is a God because I'm going to tell you something right now. I can do this and I can do that and it's all thanks to prayers, God and hard work. So my thing is never give up. We don't give up as Council people, we don't give up as colleagues, we stick together and we can get through anything. The Cianci Head Start at the Berkshire Street School, it's in my neighborhood, it's on Berkshire Street over on the opposite side of Chad Brown. I have delivered many pizzas there for the kids and one day I'm lying in bed and the nurse comes and she had this envelope and it's this high off the ground. I said what the heck is that? I thought she was giving me my walking papers because I'm not walking yet. I opened up the envelope and each one of the classrooms sent me a card and inside the card was all their little handprints with their names underneath. I felt like I hit the lottery and moved to Beverly Hills when I got that envelope. It was so great. Again, thank you very much for all your support and I feel great being back so I hope you guys are ready for me."


