No. 2 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1973-28, APPROVED JUNE 25, 1973, BY APPROPRIATING THE SUM OF ONE HUNDRED FORTY-FIVE THOUSAND SEVEN HUNDRED SEVENTY DOLLARS AND EIGHT CENTS (\$145,770.08) TO ITEM 0, VARIOUS DEPARTMENTS.

Approved January 9, 1974

Be it ordained by the City of Providence:

SECTION 1. Chapter 1973-28 of the Ordinances of the City of Providence, as approved June 25, 1973, entitled: "An Ordinance Making Appropriation of \$80,014,799.31 for the Support of the City Government for the Fiscal Period Beginning July 1, 1973 and Ending June 30, 1974", as amended is hereby further amended by appropriating the sum of One Hundred Forty-Five Thousand Seven Hundred Seventy Dollars and Eight Cents (\$145,770.08) to Item 0, in the following Departments:

SECTION 2. The said sum of One Hundred Forty-Five Thousand Seven Hundred Seventy Dollars and Eight Cents (\$145,770.08) as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer One Hundred Forty-Five Thousand Seven Hundred Seventy Dollars and Eight Cents (\$145,770.08) from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The Estimated Receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by One Hundred Forty-Five Thousand Seven Hundred Seventy Dollars and Eight Cents (\$145,770.08).

SECTION 4. This Ordinance shall take effect upon its passage.
