Changes were authorized as follows:

Sept. 8, 1952, closing of St. Joseph's and the Rhode Island Hospital Schools at the beginning of the school year, 1952-53.

#### SITES AND BUILDINGS

On January 14, 1952 the School Committee adopted the following resolution, amending preliminary drawings for the Fox Point Elementary School:

*Resolved*, That the basic specifications and basic drawings for the Fox Point Elementary School numbered job #1456, ten drawings designated A through J, approved October 8, 1951, be amended in such a way as described in the accompanying letter of January 8, 1952 from Cull and Robinson, regarding a change in the location of the boiler room.

"Dear Dr. Hanley:

Since receiving engineering reports from the City about the middle of December 1951, further analysis of the soil conditions and a fourteen foot deep test hole at the location of the proposed boiler room underneath the kitchen, as proposed in our preliminary sketches, has revealed that the location of the boiler room at this point would be unsound, since it would require tremendously massive retaining walls and reinforced concrete footings.

Analysis of the soil shows that the site was in all probability the bed of a glacial stream, and while the deposit is not organic it still must be given a silt classification. While the silt is confined and is not wetted from underground water, the bearing capacity of the soil is adequate for average loads.

However, due to the necessity of an eighteen or nineteen foot deep boiler room, there would be danger of meeting ground water at certain periods of the year, which would necessitate an extensive and costly drainage system around the footings and retaining walls at the boiler.

Therefore, for engineering reasons we have located the boiler room to the north of the locker room and have connected it by stairs and ramps to the underground pipe corridor underneath the main corridors of the school. The boiler room will extend approximately thirty-nine feet north of the north wall of the locker room and will be approximately thirty-six feet wide. The floor of the boiler room will be five feet four inches below the locker room floor and will contain boilers, incinerator, hot water storage tank, various mechanical equipment, pumps, etc., as well as janitors' locker room, toilet, and offices. The incinerator will be located at the locker room level, thus enabling the janitor to feed the incinerator via ramps rather than by vertical chutes or stairways.

On March 24, 1952 the School Committee adopted a resolution amending and approving specifications for the Fox Point Elementary School:

*Resolved*, That specifications and plans numbered Job #1456, 1 to 14 inclusive, S 13 to S 21 inclusive, 22 to 55 inclusive, P 56 to P 60 inclusive, H 61 to

H 66 inclusive and E 67 to E 75 inclusive for the Fox Point Elementary School, as amended in the following letter of March 21, 1952 from W. J. Maguire, to Cull and Robinson, be and hereby are approved:

We have received your letter of March 11, 1952, in relation to meetings at the City Hall relative to preparing plans and specifications in final form for bidding on the Fox Point Elementary School.

It was agreed that the following were not proper items for the construction and equipment cost of the project:

- Division 55-23—Garden Equipment
- " 57-21—Spare lighting bulbs or lamps
- " 58 (l)—Maps and Map Rails
- " 58 (m)—Maintenance Equipment
- " 58 (n)—Television

It was agreed that the following items should be omitted from the first contract but would be purchased by the Board of Contract and Supply from specifications prepared by you under the direction and supervision of the Superintendent of Public Buildings:

- Division 44—Curtains for Classrooms and Administration
- " 58 (a)—Classroom Equipment—Chairs, Tables, etc.
- " 58 (c)—Pianos
- " 58 (d)—Metal Desks, Chairs, and Files
- " 58 (e)—Mattresses
- " 58 (f)—Audio-Visual Equipment
- " 58 (g)—All Clinic Equipment except Items 1, 2, 3, 4, and 15
- " 58 (h)—Kitchen and Cafeteria Movable Equipment
- " 58 (i)—Business Machines and Typewriters
- " 58 (j)—Gymnasium Equipment, Movable
- " 58 (k)—Chairs and Miscellaneous Furniture
- " 58 (p)—Miscellaneous Equipment

It was agreed that there would be only one (1) Alternate in the general contract, a deductible alternate for the omission of all yard work as specified in Division 59.

It was agreed that 3/16" asphalt tile as specified for floor covering should be used.

It was agreed that no stainless steel should be used in exterior work unless stainless steel with nickel is obtainable at the time of installation. However, where stainless steel now is called for copper is to be called for.

It is agreed that there is to be no cash allowance anywhere in the specifications.

It was agreed that the Permalite Method for enclosing underground heating lines as specified shall remain and the optional method of transite pipe be omitted.

It was agreed that fluorescent fixtures throughout the building shall not be used and incandescent type fixtures will be specified.

It was agreed that the stage switchboard as specified shall be changed and one for only four (4) dimmers shall be used.

After discussing the changes with the School Committee or representative of the School Committee we will inform you of the results so that the plans and specifications in final form may be made so that bids can be obtained on the first contract.

### BRIEF STATEMENT REGARDING FISCAL YEAR FINANCES

The estimate of the School Committee for the year ending September 30, 1952, which was approved March 26, 1951, was \$6,748,335.54. Of this amount it was estimated that \$968,000.00 would come from miscellaneous receipts and \$4,972,211.68 from the current tax levy as required by law; thus making necessary, in order to meet the total estimate, an additional appropriation by the City Council of \$808,123.86.

In 1951, the City Council appropriated \$5,697,211.68 from the tax levy for the support of public schools. This amount, together with an unexpended balance of \$22,161.13 at the close of the previous fiscal year, and certain receipts required by law to be expended for public education amounting to \$986,696.77, made \$6,706,069.58 available for school purposes. This was \$407,383.51 more than the amount available for the previous fiscal year.

### SALARIES AND WAGES

The following resolution authorizing a temporary cost-of-living increase to secretaries, clerks and drivers was adopted April 14, 1952:

*Resolved*, That all secretaries, clerks and drivers whose salaries are on an annual basis and who are now in service shall receive a temporary cost-of-living increase in salary for the school year 1951-1952 at the annual rate of \$300 in addition to their regular salaries; and

*Further*, That this increase shall be retroactive to and effective as of the beginning of the school year.

On April 14, 1952, the following resolution authorizing temporary cost-of-living increase for custodial workers was adopted:

*Resolved*, That all regular custodial employees now in service, said employees to include custodians, maintenance workers, and women assistants, shall receive a temporary cost-of-living increase in wages for the school year 1951-1952 at the following annual rates, said increase to be paid on a weekly basis and to be retroactive to and effective as of September 2, 1951:

Custodians and maintenance workers.....	\$175.00
Women assistants .....	100.00

On April 14, 1952, the following resolution authorizing additional compensation for advanced degrees was adopted:

*Resolved*, That all regular certificated employees now in service who possess master's or doctor's degrees shall receive for the school year 1951-1952 in addition to their regular salaries, additional compensation at the annual rate of \$200 for those employees possessing earned master's degrees and \$400 for those employees possessing earned doctor's degrees;

*Provided*, That the employee be a permanently appointed employee whose progress on the salary schedule has not been held up for reasons other than personal illness; and

*Further*, That this resolution shall be retroactive to and effective as of the beginning of the school year.

The following resolution amending salary schedule for custodians and helpers was adopted on April 28, 1952:

*Resolved*, That the last paragraph of the Salary Schedule for Custodians and Helpers, be and hereby is amended to read as follows:

Overtime services of regular custodial and maintenance employees and drivers in connection with their regular work or in emergencies, when authorized by the Superintendent of Schools, shall be paid for at time and a half the regular hourly rates paid these employees.

*And Further*, That this resolution shall be effective from May 4, 1952.

On June 16, 1952, the following resolution authorizing a cost-of-living bonus for teachers and other employees was adopted:

*Resolved*, That all regularly employed certificated personnel and non-certificated home visitors, the supervising clerk in the Census Office, the Director of School Plant, and the Purchasing Agent, shall receive a cost-of-living bonus in addition to their regular salaries for the school year 1952-1953 at the rate of \$325 per year, effective from the beginning of said school year.

The following resolution amending the salary schedule for custodians and helpers was adopted on June 16, 1952:

*Resolved*, That the salary schedule for custodians and helpers, except the Director of School Plant, be amended by increasing the weekly wage rates in effect on October 1, 1951, by 10%; and

*Further*, That said salary schedule shall be further amended by increasing the hourly wage rates for student helpers to 50¢ per hour, and for women assistants to 96¢ per hour, and

*Further*, That said salary schedule shall be further amended by increasing the hourly rates for custodians and assistant custodians in evening school to \$1.50 per hour; and

*Further*, That said salary schedule shall be further amended by increasing the hourly rates paid to custodians or assistant custodians for their services in connection with coordinate activities or auxiliary agencies when authorized by the Superintendent of Schools to time and a half the regular hourly rates paid these employees; and

*Further*, That said salary schedule shall be further amended by including the following provision: Compensation paid to custodial personnel by outside groups using public school facilities shall be at the rate of time and a half the regular hourly rates of these employees, and shall be based on actual time served, with a maximum of \$2.00 per hour; and

*Further*, That the foregoing amendments to said salary schedule shall be effective August 24, 1952.

The following resolution was adopted on June 23, 1952, amending the salary schedule for secretaries, clerks, and drivers:

*Resolved*, That the salary schedule for all secretaries, clerks, and drivers on a 12-month basis be amended, effective September 1, 1952, by increasing the maxima of classes A to E inclusive by \$300, and that the annual salary rates of all 12-month secretaries, clerks, and drivers shall be increased by \$300, effective September 1, 1952; and

*Further*, That the salary schedule for all secretaries and clerks on a 10-month basis shall be amended, effective September 1, 1952, to read as follows:

The maximum salaries for these positions shall be reached in accordance with the schedule set forth below.

No clerk may advance an additional step beyond \$1900 except on recommendation of the Superintendent.

*And Further*, That to effect the above salary schedule the annual salary rates of all 10-month secretaries and clerks shall be increased by \$300, effective September 1, 1952.

On September 2, 1952, the following resolution amending the salary schedule for principals, assistant principals, supervisors and directors was adopted:

*Resolved*, That the salary schedule be amended by adding the following provision after II Application 6:

7. Principals of elementary schools of more than 40 teacher units, \$1600 above the basic salary.

And, by renumbering the subsequent applications.  
Effective September 1, 1952.

On September 22, 1952, the following resolution authorizing additional compensation for advanced degrees was adopted:

*Resolved*, That all regular certificated employees now in service who possess master's or doctor's degrees shall receive for the school year 1952-1953 in addition to their regular salaries, additional compensation at the annual rate of \$200 for those employees possessing earned master's degrees and \$400 for those employees possessing earned doctor's degrees;

*Provided*, That the employee be a regularly appointed employee whose progress on the salary schedule has not been held up for reasons other than personal illness.

The following resolution authorizing a cost-of-living bonus for teachers and other employees was adopted on September 22, 1952:

*Resolved*, That Resolution No. 400, adopted June 16, 1952, be amended to read as follows:

*Resolved*, That all regularly employed certificated personnel and non-certificated home visitors, the supervising clerk in the Census Office, the Director of School Plant, and the Purchasing Agent, shall receive a cost-of-living bonus in addition to their regular salaries for the school year 1952-1953 at the rate of \$375.00 per year, effective from the beginning of said school year.

On September 22, 1952, the following resolution amending the Salary Schedule for Evening Schools was adopted:

*Resolved*, That the Salary Schedule for Evening Schools shall be amended to read as follows:

#### EVENING SCHOOLS

The following salaries are the maximum salaries authorized which the actual salaries may not exceed.

An increase in any salary, not exceeding one dollar per evening, may be made annually by authority of the Superintendent.

Substitute teachers shall be paid \$5.00 per two hour session, and regular evening school teachers who serve as substitutes shall be paid at their regular rate.

Substitute clerks shall receive not exceeding \$3.00 per two-hour session.

#### OUTSTANDING ITEMS TAKEN FROM THE RECORDS OF THE SCHOOL COMMITTEE

On February 11, 1952, the School Committee adopted the following resolution authorizing a contract with Providence College, Providence, Rhode Island, providing for the training of undergraduate students:

*Resolved*, That the Superintendent as agent of the School Committee be and hereby is authorized to enter into an agreement with the Department of Education of Providence College, providing for the training of undergraduate students in the elementary and secondary schools.

The following resolution providing emergency cost-of-living bonus for school employees was adopted February 11, 1952:

*Resolved*, That the City Council and Mayor be and hereby are requested to provide an additional emergency appropriation of \$300,000, to provide an emergency cost-of-living bonus for every full-time and regularly appointed employee of the School Department, for the current school year; and

*Further, Be It Resolved,* That the School Committee be permitted to file its budget within a reasonable time after the issuance of the report and recommendations of the Mayor's Survey Commission, instead of during the month of March as provided by law.

On March 24, 1952, the Committee received the following resolutions from the City Council which were approved on February 25, 1952:

*Resolved,* That His Honor the Mayor is hereby authorized and directed to execute an agreement substantially in accordance with the accompanying draft instrument, cancelling Contract No. H(100) 17-50, dated June 14, 1950, between City of Providence and United States of America, under which contract the City of Providence received advance planning funds for proposed school in Fox Point Section of the City of Providence.

*Whereas,* There has been presented to the City Council a resolution adopted by the Providence School Committee requesting an additional appropriation of \$300,000 to provide bonuses to teachers, clerks and janitors in the school system; and

*Whereas,* It is a well-known and easily ascertainable fact that the revenues and expenditures of the City of Providence are planned and executed on an annual basis beginning October first in each year, and that for the current fiscal year the sum of \$300,000 or any other substantial amount is not now available for appropriation; and

*Whereas,* The City Council has recognized the importance of the school finance problem by authorizing the appointment of a special commission to examine into all aspects of the problem and to make recommendations thereon, and that a commission was appointed and has worked diligently and is soon to report its findings and recommendations; and

*Whereas,* Without curtailing other essential services the City Council cannot meet the request of the Providence School Committee and others for additional funds;

*Now, Therefore, Be It Resolved,* That it is the policy and declared position of this City Council, (1) that it be clearly understood by all concerned that the City does not have \$300,000 in unappropriated funds, that it cannot obtain \$300,000 for the current fiscal year, and that it has no authority to incur an indebtedness of \$300,000 or any similar sum for school purposes, and therefore it cannot comply with the request of the school committee. (2) That the City Council will receive and give careful consideration to the report of the special commission now studying the operation of the school system, and in the event it is deemed necessary and advisable in the opinion of this Council to seek immediate revisions in the laws controlling the finances of the City and the School

Committee, a special election will be called promptly under the provisions of the home rule amendment of the State constitution to afford the voters an opportunity to vote upon such revision in the law. (3) That the City Council and the City's administrative officers will accept and recognize the budget request of the school department for the 1952-1953 fiscal year at any time prior to final preparation of a recommended budget for general City purposes by which date opportunity should have been provided for such consideration and action on the report of the special commission as may be necessary and advisable.

On September 8, 1952, the following resolution amending Regulations of the School Committee *re* sick leave allowances was adopted:

*Resolved*, That Resolution No. 398, adopted June 16, 1952 be and hereby is amended to read as follows:

*Resolved*, That Resolution No. 364, adopted April 14, 1952, be and hereby is amended to read as follows:

*Resolved*, That Section 1 of Article VI of the Regulations of the School Committee be and hereby is amended as follows:

Effective September 3, 1951, teachers, home visitors, nurses, school clerks and all other regular full-time employees of the School Department whose salaries are paid on a ten-month basis who are absent because of personal illness

shall receive full pay for the first three days of such absence in each school year, cumulative to 15 days.

Such employees shall be credited with three days at the beginning of each school year and shall be charged for each day used until all the days then credited to their accounts (not to exceed 15 days) shall have been used, after which such employees shall not be entitled to further sick leave at full pay until the beginning of the next school year.

When the days of sick leave at full pay have been exhausted such employees shall be entitled to the regular sick leave allowances now in effect.

When such an employee has a credit of more than 12 days at the end of any year a credit shall be entered at the beginning of the next year of such number of days as will bring the total credit to 15 days. In any year when such employee commences the year with a credit of 15 days he shall be charged with the number of days used during that year and shall not be credited with any more days until the beginning of the next year, when a credit shall be entered for three days or the number of days required to restore the credit balance to 15 days, whichever is less. For example, such an employee who commences the year with a credit of 15 days and uses 8 days during the year shall be credited with 3 days at the beginning of the next year; whereas, if such an employee had used one day during the year he would be credited with only one day at the beginning of the next year.

It is the intent of the School Committee that the maximum number of days of sick leave at full pay shall be 15 and that not more than three days shall be credited in any school year.

*Further,* That the period during which the provisions of this resolution shall be effective shall terminate on June 19, 1953 unless extended or made a permanent part of the salary schedule by action of the School Committee prior to that date.

On September 22, 1952, the following resolution authorizing amendment to contract regarding the training of teachers was adopted:

*Resolved,* That the Superintendent, as Agent of the School Committee, be and hereby is authorized to effect an amendment to the agreement with Bryant College to provide training for undergraduate students and training schools in the senior high schools, to date from the beginning of the present school year.
