

SECTION 1. Notwithstanding the language of Section 17-189(6) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident," the Retirement Board of the City of Providence, may consider and act upon the accidental disability retirement application of Tydell Johnson, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards and practices relating to accidental disability retirement applications.

SECTION 3. This Ordinance shall take effect upon its passage.

Resolution Renaming the Neutaconkanut Park Recreation Center the A. Vincent Igliazzi Recreation Center.

WHEREAS, A. Vincent Igliazzi was a life-long resident of Providence's Silver Lake neighborhood; and

WHEREAS, He graduated from La Salle Academy, and upon graduation, he served his country with distinction during the Korean War and then attended Bryant College to study business; and

WHEREAS, He led a life committed to public service and was the Director of Administration for the State of Rhode Island State Equal Opportunity Office and Federal Programs Coordinator, Assistant Director of Administration for the State of Rhode Island, and the Deputy Clerk to the Rhode Island House of Representatives. He was cited for numerous professional achievements and served as President of the International Personnel Management Association and executive board member of the National Institute of Employment Security. He was a member of the Rhode Island Manpower Service Council, as well as a member of the Commission of Comparable Worth; and

WHEREAS, He was one of the founders and Chairman of the Silver Lake Annex Hope Neighborhood Association for 33 years; and

WHEREAS, He served as chairman of the Diocese of Providence Catholic School Board, Training thru Placement Program for the developmentally disabled, Silver Lake Lions Club, Grand Lodge Columbus Day Observance Committee, and served on the St. Bartholomew Church fund-raising committee; and

WHEREAS, He was the past president of the St. Bartholomew's Parish School Board, Silver Lake Lions Club and the Loggia Piave Sons of Italy; and

WHEREAS, He was also a member of the Hope Council Knights of Columbus, the Rosario Society, the Rhode Island Jimmy Fund, Saint Bartholomew's Society, the Italo-American Club, and the Holy Name Society. He was a lifelong parishioner and Lector of Saint Bartholomew Church; and

WHEREAS, he was the secretary of the Providence Civic Center Authority as well as a member of the Silver Lake/Hartford Revitalization Committee; and

WHEREAS, In 1972, he revitalized the Piave Lodge which had been inactive for years and was elected President; he was eventually was elected to the post of Trustee of the Rhode Island Grand Lodge, Order Sons of Italy in America. In 1993, he was awarded the Loggia Piave Merit Award; and

WHEREAS, In October of 1986 he was nominated, awarded and honored as humanitarian, community leader and neighborhood honoree at the Providence 350: Grand Jubilee Ball; and

WHEREAS, He led The Citizens Education Committee on Property Tax Reform in 1988; and

WHEREAS, As a longtime member of the Providence Democratic Committee, he was elected Secretary in 2011 and served in this position until his passing; and

WHEREAS, He also served as Chairman of the Ward 7 Democratic Committee and continued to serve until his passing; and

WHEREAS, He was admired and respected by all who knew him, particularly for his political knowledge; and

WHEREAS, On July 14, 2019, A. Vincent "Vinnie/Sonny" Igliazzi passed away at the age of 86; and

WHEREAS, Renaming the Neutaconkanut Park Recreation Center in honor of A. Vincent Igliazzi would be a fitting tribute to the life and work of such a dedicated public servant.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Providence does hereby rename the Neutaconkanut Park Recreation Center, located at 675 Plainfield Street, the "A. Vincent Igliazzi Recreation Center."

Resolution Recognizing and Remembering the Life and Legacy of Mr. Michael Van Leesten.

WHEREAS, Michael Van Leesten was a long-time resident of Providence who passed away on August 23, 2019 at the age of 80; and

WHEREAS, He graduated from Hope High School, and upon graduation he served his nation as a communications specialist in the United States Airforce, upon discharge he attended Rhode Island College where he was a star basketball player; and

WHEREAS, Upon his graduation from Rhode Island College he became active in the Civil Rights Movement and participated in SCLC SCOPE Project in Choctaw County, Alabama; and

WHEREAS, He along with six other college students worked doing community organizing and voter registration in rural Alabama during the height of the Civil Rights Struggle; and

WHEREAS, He spoke of his time in the Movement as a “defining moment in my life”; and

WHEREAS, He believed that singular experience made him a better person, better husband, better father, and better community leader; and

WHEREAS, He served as the Executive Director of Opportunities Industrialization Center (OIC) of Rhode Island, which he helped found, for more than 15years; and

WHEREAS, He also worked as a consultant as the owner of Van Leesten Associates; and

WHEREAS, He served as the Director of Planning and Development in Providence; and

WHEREAS, He then went on to be the Director of Public Affairs for the Mashantucket Pequot Tribe from; and

WHEREAS, He resumed his role of the OIC from 2006 until his passing; and

WHEREAS, He was board member of numerous organizations including the Board of Regents, Peerless Precision, and Fleet Bank; and

WHEREAS, He was awarded honorary doctorate degrees from Roger Williams College, Rhode Island College, and the University of Rhode Island; and

WHEREAS, He is survived by his former spouses Natalie E. Brown, Andrea G. Van Leesten, and Paula Van Leesteen, and his loving children Jill, Michael, Ayyub, Andrew, Jordan, and Alexis, and his beloved grandchildren Aliza, Aaron, Az-Zubair, and Huria, and his siblings Rashad Munir, David Van Leesten, Lisa Van Leesten, and Dorothy “Dee Dee” Van Lesten; and

WHEREAS, He was predeceased by his brother Karriem Muhammad (ne Hendrik Van Leesten Jr.) and both his beloved parents.
