That whereas there have been five increases in the tax rate in the City of Providence in the last ten years, and also, several increases in revaluations of real estate, and

WHEREAS, said increases have reached alarming proportions to a point where it is now extremely difficult for people in this city to own or rent property,

NOW, THEREFORE, BE IT RESOLVED, that a Special Committee of five (5) members of the City Council, not less than two of said members shall be of the minority party, be hereby appointed by the President for the purpose of studying the feasibility of either reducing the tax rate or the 80% factor of real estate valuations, or the possibility of a reduction in both categories, so that a more realistic tax structure can be achieved, and

BE IT FURTHER RESOLVED, that a survey of the cost of governmental operations be effected with a view of possible economies in the several departments.


