

Re: Lien on 41 Somerset Street

I have reviewed the records for the building located at 41 Somerset Street, on Assessors Plat 23, Lot 39. This property was first found vacant on January 4, 1973. I will spare you the litany of ownership changes, fires and correspondence that has taken place since that time. Needless to say that the file for this particular building is almost one inch thick.

Just recently, SWAP has purchased this property, demolished it at their own expense and are replacing the previous building with a new structure. This act alone has saved the City \$2,150 for the demolition and \$1,500 for the removal of asbestos in the building.

I recommend that the Committee on Finance approve the petition for waiving the lien in the sum of \$367.00.

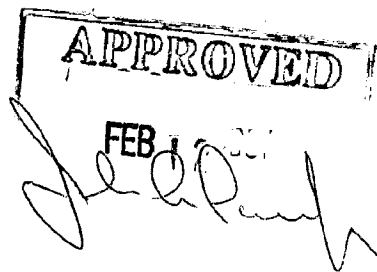
