AN ORDINANCE IN AMENDMENT OF CHAPTER 1987-10 OF THE ORDINANCE OF THE CITY OF PROVIDENCE, AS APPROVED MAY 11, 1987, AS AMENDED IN CHAPTER 1988-45, NOVEMBER 23, 1988, AS AMENDED IN CHAPTER 1989-18, APRIL 17, 1989; ENTITLED "AN ORDINANCE CREATING AND ESTABLISHING AN ECONOMIC DEVELOPMENT ZONE WITH IN THE CITY OF PROVIDENCE PURSUANT TO 3-7-16.4 OF THE GENERAL LAWS OF THE STATE OF RHODE ISLAND," AS AMENDED.

Approved April 30, 1995

Be it ordained by the City of Providence:

WHEREAS, the City Council, pursuant to Rhode Island General Laws Section 3-7-16-4, created and established an economic development zone necessary for the purpose of encouraging commercial and industrial investment; and

WHEREAS, the boundaries of said economic development zone were set forth in Exhibit A of Chapter 1988-45, attached thereto and incorporated by reference; and

WHEREAS, the City Council desires to modify the boundaries of said economic development zone;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PROVIDENCE:

That portion of the economic development zone located "Number 1" attached and incorporated by reference in Chapter 1988-45 as amended, is hereby amended pursuant to R.I.G.L. 3-7-16.4 as described in Exhibit "A" and shown in Exhibit "B" which are attached hereto for the purposes of licensing Class ED Retail Alcoholic Beverages Licenses.

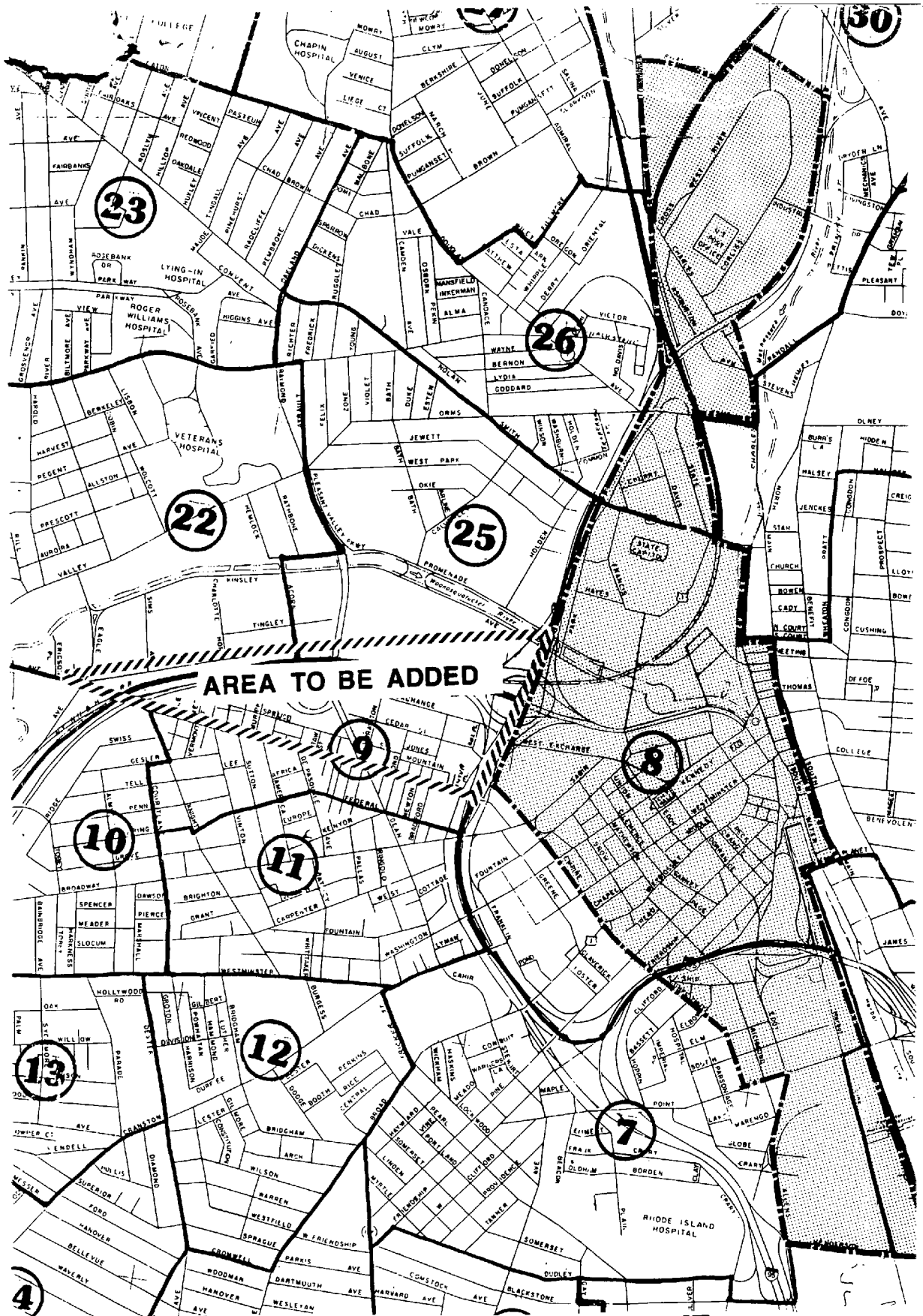

1980 Census Tract Lines

By Request
Proposed New ED Zone

Beginning at a point, that point being the Intersection of the southerly line of Smith Street and the easterly taking line of Interstate Route 95;

Thence running in a general southwesterly direction along the easterly taking line of Interstate Route 95 to the centerline of Kingsley Avenue;

Thence turning and running northwesterly in part along the southerly line of Kingsley Avenue to its intersection with the southerly line of Harris Avenue;

Thence turning and running westerly along the southerly line of Harris Avenue to its intersection with the southerly line of Atwells Avenue;

Thence turning and running easterly along the southerly line of Atwells Avenue to the easterly taking line of Interstate Route 95;

Thence turning north taking the easterly line of Interstate Route 95 to the point and place of beginning(southerly line of Smith Street).
