Dept.--Engineering Office, City Property Section, Plan No. 061771, Date October 29, 1958," has ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and so awarded, and it is further,

ORDERED, that the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed on that portion of Caxton Street from a point twenty feet east of the easterly line of Carder Street to the westerly line of Wild Street, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, September 9, 1958.

This referral is a request for the abandonment of Caxton Street from Carder Street to its easterly termination. We are advised by the petitioner that the purpose of this request is to consolidate and improve the parking area for St. Edward's Parish located between Carder and Wild Streets. Inasmuch as it would appear necessary to retain Caxton Street east of Wild Street to permit access to Caxton Street by abutting owners, and inasmuch as the purpose of the Parish would appear to be served by abandonment of Caxton Street from Carder Street to Wild Street,

The Commission

VOTED: To offer no objection to the abandonment of this portion.

It is also recommended that the Parish be contacted and requested to convey to the City of Providence, in return for said abandonment, a twenty-foot strip on the east side of Carder Street and Bingham Street for the purpose of increasing the widths of these streets to forty feet and permitting adequate access to Branch Avenue from Burton Street.

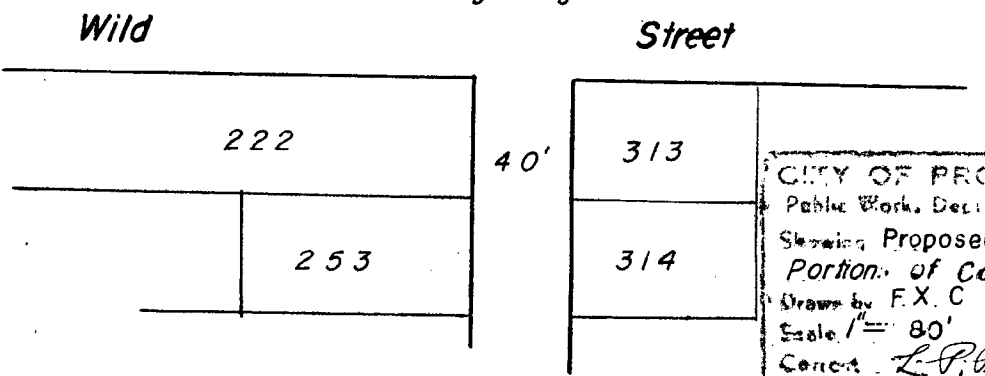
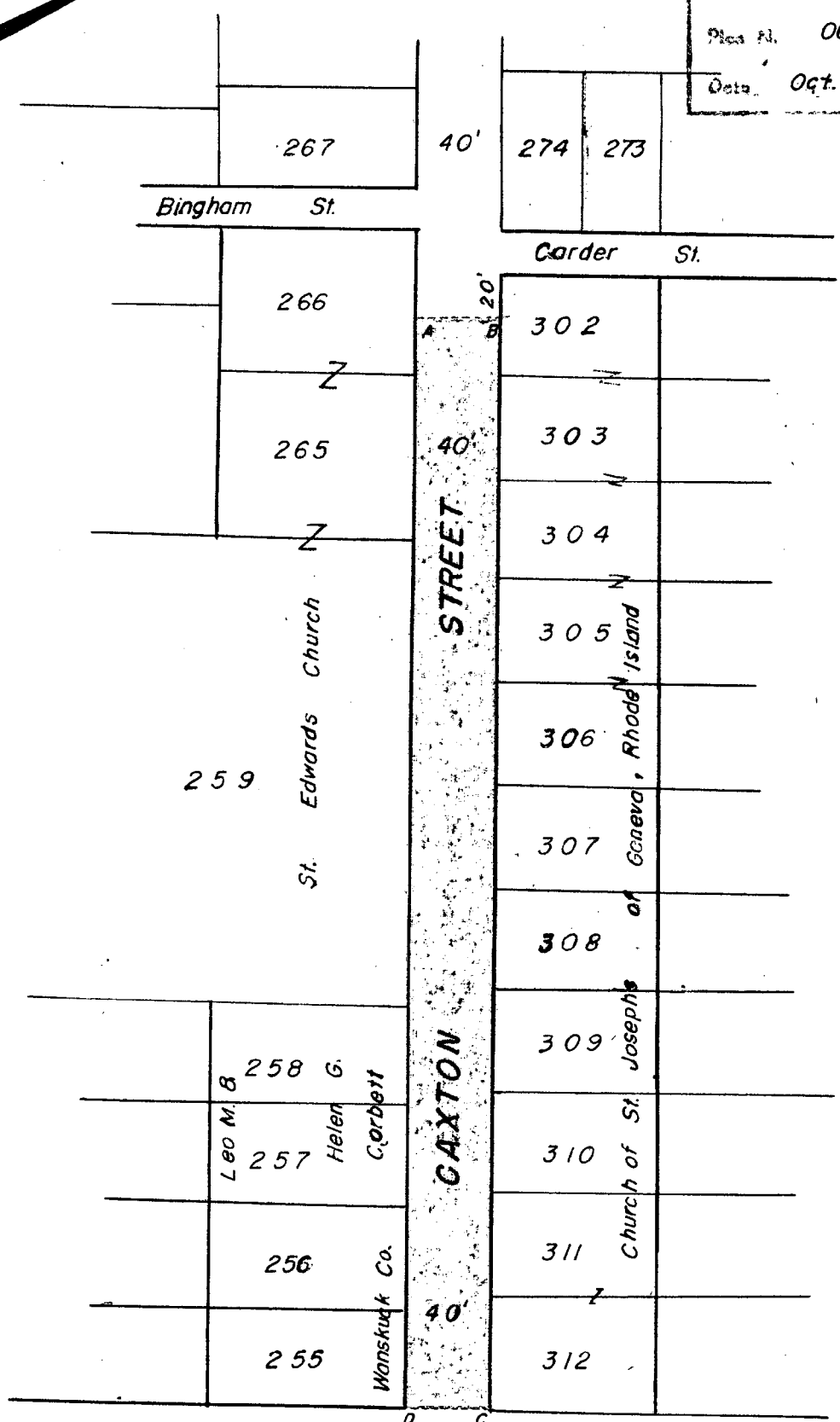
