

RESOLUTION OF THE CITY COUNCIL

Approved August 8, 1973

RESOLVED, DECREED and ORDERED,

That the portion of Brayton Avenue, from the northerly line of Dean Street to the Southerly line of Spruce Street, as shown as cross-hatched area and designated by the letters A-B-C-D-A, on accompanying Plan No. 063784, date June 19, 1973, has ceased to be useful to the public, is hereby abandoned, as a public highway and the damage to the abutters is appraised at nothing and is so awarded, subject to that easement acceptable to the Director of Public Works, relative to existing eighteen (18") inch storm sewer, as incorporated in correspondence addressed to the Committee on Public Works of the City Council, dated July 20, 1973, which is hereto attached; and further subject to that easement acceptable to the Water Supply Board, as incorporated in correspondence addressed to the Committee on Public Works of the City Council, dated August 1, 1973, which is hereto attached, and further subject to that easement, as incorporated in correspondence addressed to the Committee on Public Works of the City Council, dated July 6, 1973 from the Narragansett Electric Company which is hereto attached, relative to an overhead pole located along the easterly side of said portion of Brayton Avenue, provided however, that this easement shall be granted only upon the condition that the said Company cause its service to be installed underground, and it is further

ORDERED, That all other Public utility service along said portion of Brayton Avenue be also installed underground, and

ORDERED, That the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the portion of Brayton Avenue, abandoned as aforesaid, having thereon the words, "Nota Public Highway", and it is further


Dear Councilman Payne:

On May 22, 1973 we received a memorandum from the City Clerk's office with regard to a petition filed by Church of Our Lady of Mt. Carmel, Providence to abandon as a Public Highway that Portion of Brayton Avenue from the Northerly Line of Dean Street to the Southerly Side of Spruce Street.

We have arrived at a cost estimate of forty-seven thousand, one hundred and seventy one dollars (\$47,171.00) to relocate the existing water facilities in the section of the street to be abandoned.

A bill for the above amount will be filed with the City Collector's office and we respectfully request that your Committee take no action on this matter until the Water Supply Board is assured of payment for the required relocation of its mains and appurtenances.



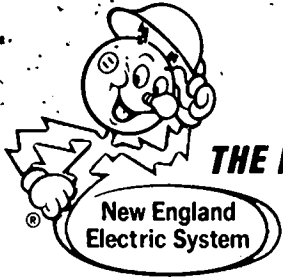

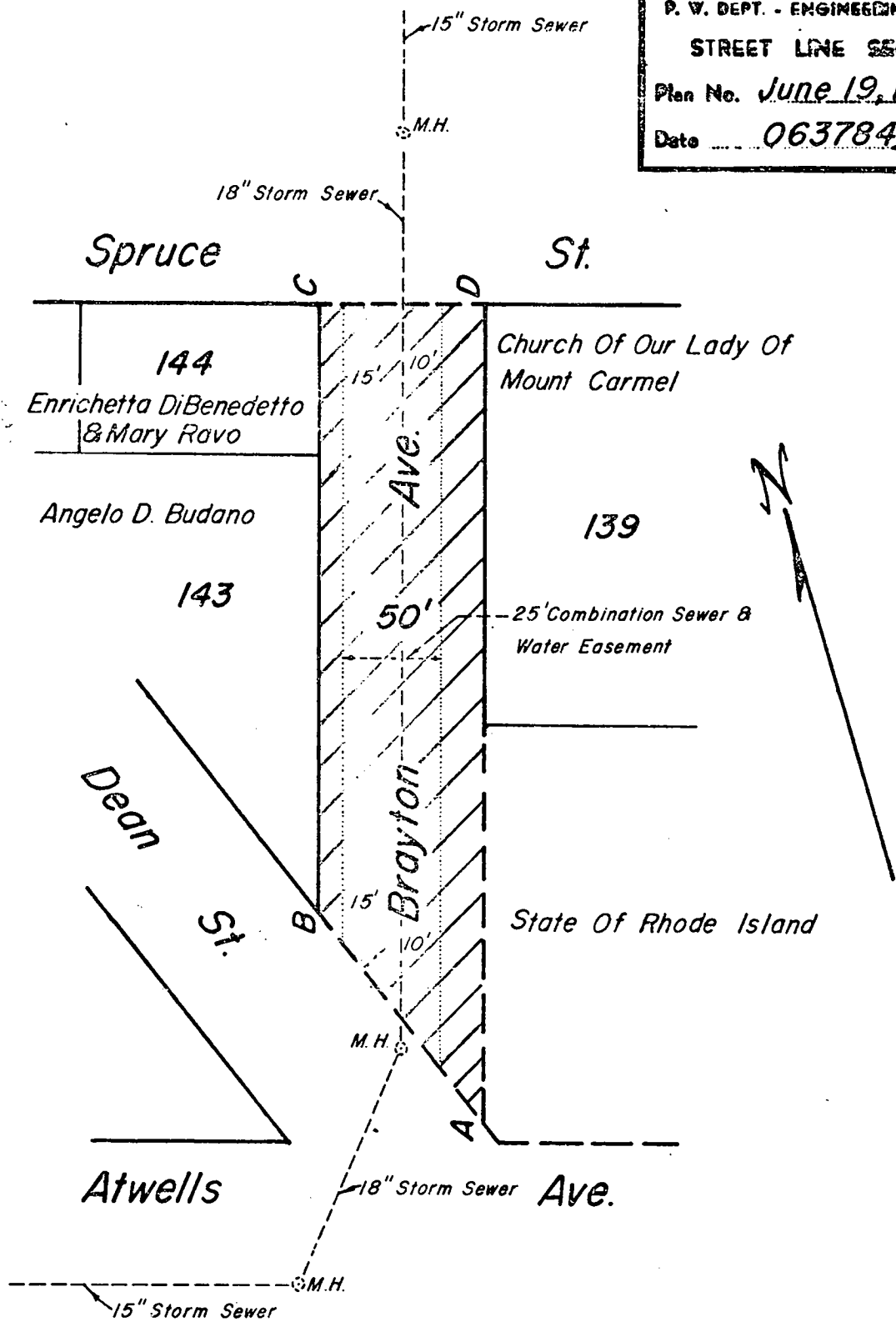
