WHEREAS, There is no apparent relief in sight either for the municipal budgets, for the working taxpayers who must shoulder the burden, or for the employers who strive to provide the ever-more-costly benefits for their employees and their families; and

WHEREAS, Many of the people who have had their health coverage benefits from their private sector employers reduced or eliminated are unable to afford to pay for a similar benefits on their own, leaving them in the quandary of working to provide benefits for families in the public sector while lacking the ability to provide the same for their own; and

WHEREAS, It is the rightful duty of the General Assembly of the State of Rhode Island to provide for the health and well being of all of the citizens of the State of Rhode Island; and







**RESOLUTION TO THE GENERAL ASSEMBLY RELATIVE TO ACCESS AND AFFORDABILITY OF HEALTH CARE**

RESOLVED , that

WHEREAS, the skyrocketing costs of health care, prescription medications and health insurance have left many citizens of the Town of Richmond, and throughout the State of Rhode Island, without adequate medical care; and

WHEREAS, due to these skyrocketing costs, many employers have been forced to reduce or eliminate access to health care coverage to their employees and their families; and

WHEREAS, many of the citizens of the Town of Richmond who are without adequate health care and health insurance coverage are the most needy, in particular children and senior citizens; and

WHEREAS, many of the people who have had their health coverage benefits from their employers reduced or eliminated are unable to afford to pay for comparable or adequate coverage on their own, thus leaving entire families without adequate health insurance coverage and health care; and

WHEREAS, this is a matter of paramount importance to the health, safety, welfare and economic vitality of the citizens of the Town of Richmond, State of Rhode Island and the United States of America.

NOW, THEREFORE, BE IT RESOLVED, the Town Council of the Town of Richmond hereby requests the General Assembly to thoroughly investigate and develop mechanisms and implementation strategies to effect such control and mitigation of health care and health insurance costs without denigration of health care quality. It shall also be resolved that the General Assembly is petitioned to enter into an open dialogue with the city and town councils of the State of Rhode Island so as to generate a pragmatic and expeditious solution to the health care crisis.

The Town Clerk of the Town of Richmond is hereby directed to forward a copy of this Resolution to the Senators and Representatives from the Town of Richmond and to each city and town councils in the State of Rhode Island.






