Best wishes in your efforts to secure this much needed program for the Providence School system.

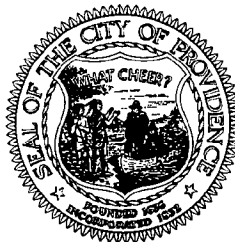
